



Station Response Percentages








Significant Response Activity

On 12/7/17 @ 11:42 hours, CCFD Fire and EMS responded to Children's Hospital South for a reported bomb threat. Upon arrival, crews met with Springboro PD and staged a command post across the street while police evacuated the building. Police officers apprehended the person allegedly making the threat and after a search of the building discovered no bomb or other issues.

On 12/12/17 @ 14:22 hours, CCFD Fire and EMS responded to East State Route 73 for a reported non-breather. Upon arrival, crews found a 47-year-old female not breathing. Prior to crew arrival, patient received CPR from a friend followed by Clearcreek Township PD taking over CPR and placing AED on patient. Crews initiated Advanced Life Support Protocols and contacted the medical control Physician who issued a field termination of resuscitation order.

On 12/16/17 @ 05:01 hours, CCFD Fire and EMS responded to East Central Avenue for a reported non-breather. Upon arrival, crews found a 98-year-old male unresponsive and receiving CPR. Crews initiated Advanced Life Support Protocols and contacted the medical control physician who issued a termination of resuscitation order. On 12/17/17 @ 12:41 hours, CCFD Fire and EMS responded to Foliage Lane for a reported non-breather. Upon arrival, crews found a 50-year-old male not breathing and pulseless. Crews initiated Advanced Life Support protocols and transported the patient to Sycamore Hospital.

On 12/22/17 @ 15:31 hours, CCFD Fire and EMS responded to College Hill Terrace for a reported structure fire. Upon arrival, crews found a working fire with moderate smoke coming from a two-story residential building. All occupants evacuated the home. Crews advised the source was from a grease fire in kitchen, where crews located the fire and noted extension onto the floor and cabinet area of the kitchen and into the living room. Crews controlled the fire using a dry chemical extinguisher with a hand-line available for back up. Crews extinguished the fire, performed salvage and overhaul. Miami Valley Fire District provided mutual aid assistance. Estimated property damage was \$200,000.



On 12/25/17 @ 22:42 hours, CCFD Fire and EMS responded to Rio Vista Court for a reported structure fire. Upon arrival, crews found no fire showing but noted a significant amount of smoke. Police officers advised crews that the fire started from a candle located in the basement. Crews preformed overhaul and ventilation and noted smoke damage throughout the basement. Estimated property loss was \$10,000.

On 12/29/17 @ 06:47 hours, CCFD Fire and EMS responded to Cherry Street for a reported unconscious/unresponsive person. Upon arrival, crews found a 72-year-old male pulseless and not breathing. Crews initiated Advanced Life Support Protocols and the patient regained a pulse. Crews transported the patient to Kettering Franklin Emergency Center.


