




Total Alarms


Alarms by Service Type



Average Response Times



SIGNIFICANT RESPONSES

On 12/3/23 @ 22:06 hours, crews responded mutual aid into Lebanon for a reported structure fire. Upon arrival, crews found a commercial building with fire in a rooftop vent. Crews assisted with water supply until released by command.

On 12/6/23 @ 14:50 hours, crews responded mutual aid into Wayne Township for a reported building fire. Upon arrival, crews found a residence with smoke and flames showing from the chimney. Crews assisted with extinguishing the fire before checking for extension and performing overhaul.

On 12/12/23 @ 09:03 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Clearcreek PD.

On 12/12/23 @ 10:10 hours, crews responded to a business for reported breathing problems. Upon arrival, crews found a patient showing stroke symptoms. Crews initiated ALS procedures and transported the patient to Atrium Medical Center.

On 12/13/23 @ 00:39 hours, crews responded mutual aid into Franklin for a reported building fire. Upon arrival, crews found a residential building with active fire. Crews assisted with interior ventilation and extinguishing hot spots until released by command.

On 12/13/23 @ 10:22 hours, crews responded to a restaurant for a reported cardiac arrest. Upon arrival, crews found a patient receiving care from a bystander after choking. Crews initiated ALS procedures and transported the patient to Atrium Medical Center.

On 12/19/23 @ 06:13 hours, crews responded mutual aid into Franklin for a reported building fire. Upon arrival, crews found an apartment building with active fire. Crews assisted in checking for extension on the second floor and extinguishing hot spots until released by command. Crews returned to the site to assist fire investigators by assessing a floor collapse for stabilization.



On 12/20/23 @ 16:27 hours, crews responded mutual aid into Wayne Township for a reported building fire. Upon arrival, crews found a grain bin with smoke showing. Crews assisted in extinguishing the fire until released by command.



On 12/22/23 @ 05:23 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest. Crews initiated ALS procedures and transported the patient to Atrium Medical Center.

On 12/25/23 @ 20:15 hours, crews responded to Hart Road and West State Route 122 for a reported motor vehicle accident with injuries. Upon arrival, crews found one SUV rolled over. Crews stabilized the vehicle and transported one patient to Dayton Children's Hospital South. Turtlecreek Township transported two additional patients. Crews cleared the site of hazards and released the scene to Clearcreek PD. Lebanon Fire and Turtlecreek Township provided mutual aid assistance.



Crews contacted the coroner and released the scene to Springboro PD.
