

The cause of the fire was determined to be electrical in nature. Damage was estimated at \$80,000.00 to the structure and contents.







October



No new plans were reviewed during the month of November 2003.


December

The Career Lieutenant Selection process continued with initial interviews being conducted on 9/10/03. An assessment center test was conducted for qualified applicants on 9/20/03.

Initial interviews for the part-time Administrative Assistant position were conducted on 9/23/03.

The Fire District completed design specification for the Station #23 telephone system. The hardware was recently installed.

The Fire District participated in several meetings with the Warren County Telecommunications Department to design and specify a microwave connectivity link for Station #23 and possible future connectivity for all stations.

Work continued on developing and reconfiguring the Fire District's Box Alarm Zone Maps into a 3 Station response model. This new system relies heavily on use of Global Information System (GIS) data and Arc-view Software. Bureau Chief Simpson with the assistance of Clearcreek Township Director of Planning Zoning Jeff Palmer and the Warren County GIS Department has been working on this project since early July.

October

The Rural Address Locator Sign Program continued with 6 signs being installed during October, 2003.

An open house was held at Station 22 on October 5. Over 100 people toured their new station and enjoyed lunch, talked with firefighters and visited with Sparky the Fire Dog.

The Clearcreek Fire District was active with the Lion's Club passing out candy on Beggar's Night, October 31.

The Community Blood Bank was held on October 23 at the Clearcreek Fire District. We had an overwhelming amount of donors.

The Clearcreek Fire District participated in the Township wide Alpha Pager switch out on October 31.

The Clearcreek Fire District Fire Prevention Program implemented the Red Tag Program on October 1. This program tags defective equipment and helps to identify similar defective items for the fire investigators

October was Fire Prevention Month and the Fire District participated in numerous talks and tours with the area schools.

November

The Rural Address Locator Sign Program continued with 1 sign being installed during November, 2003.

The Career Lieutenant Selection process concluded with the promotion of Steve Agenbroad and Nathan Urban to Career Lieutenants, and the hiring of Kent Clary as a Career Lieutenant on November 14, 2003.

The Fire District opened Fire Station #23 on 11/22/03.

Work was completed on developing and reconfiguring the Fire District's Box Alarm Zone Maps into a 3 Station response model for the Warren County Communications Center CAD System. This new system relies heavily on use of Global Information System (GIS) data and Arc-view Software. Bureau Chief Simpson with the assistance of Clearcreek Township Director of Planning Zoning Jeff Palmer and the Warren County GIS Department worked on this project since early July.

Work was completed on reconfiguring the Warren County Communications Center CAD System Response Tables to include 74 response zones for the Clearcreek Fire District in preparation for a switch over to unit dispatching later this year.

Chief of Department Becker, Assistant Chief Royer, and Bureau Chief Simpson attended the OLS Responder Officer Leadership Symposium in Fort Mitchell Kentucky on 11/8/03 and 11/9/03. This program included well know speakers in the topics of Fire Operations, Fire Department Management, Leadership Development, Incident Command, Terrorism Preparedness, Chemical and Biological Weapons Response, and Joint Operational Command.


December




The Fire District met with representatives from Health Serve concerning the implementation of the recently approved MVA cost recovery program.
