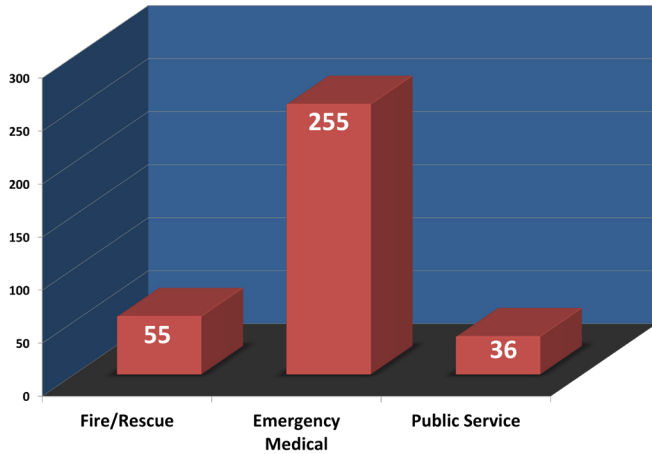

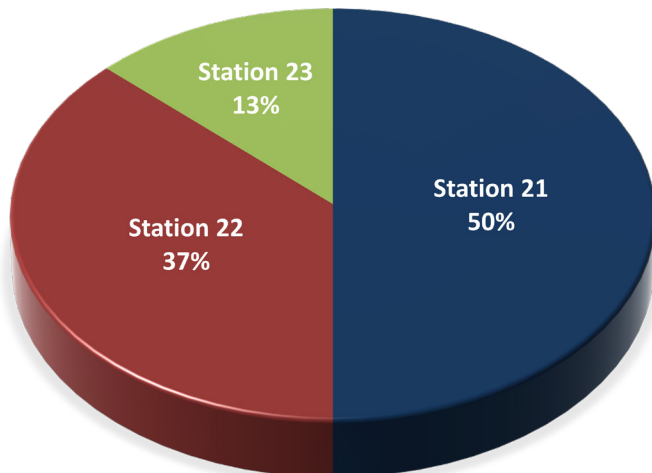
Alarms by Service Type

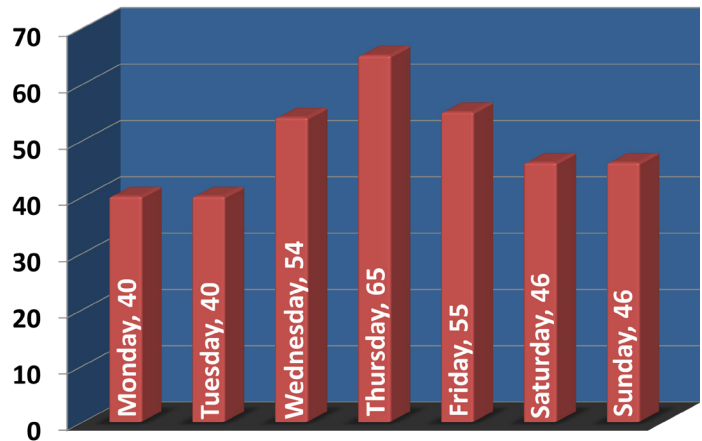
Response Percentages

Significant Responses

On 3/8/24 @ 16:21 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Clearcreek PD.

On 3/12/24 @ 12:03 hours, crews responded to Lytle Five Points Road for a reported person down. Upon arrival, crews found a patient in cardiac arrest with bystanders performing CPR. Crews initiated ALS procedures and transported the patient to Kettering Health Main Campus.

On 3/13/24 @ 21:55 hours, crews responded to a residence for a reported fall. Upon arrival, crews found a patient in cardiac arrest. Crews initiated ALS procedures and transported the patient to Atrium Medical Center.

On 3/17/24 @ 22:04 hours, crews responded mutual aid into Franklin for a reported structure fire. Upon arrival, crews found an apartment building with fire showing. Crews assisted in extinguishing the fire. Once the fire was under control, crews assisted in searching for and extinguishing hot spots inside the building. Crews aided in overhaul until released by command. At 03:42 hours, crews responded back to the Franklin site for reported rekindling of the fire. Crews used the aerial ladder to extinguish flare-ups.

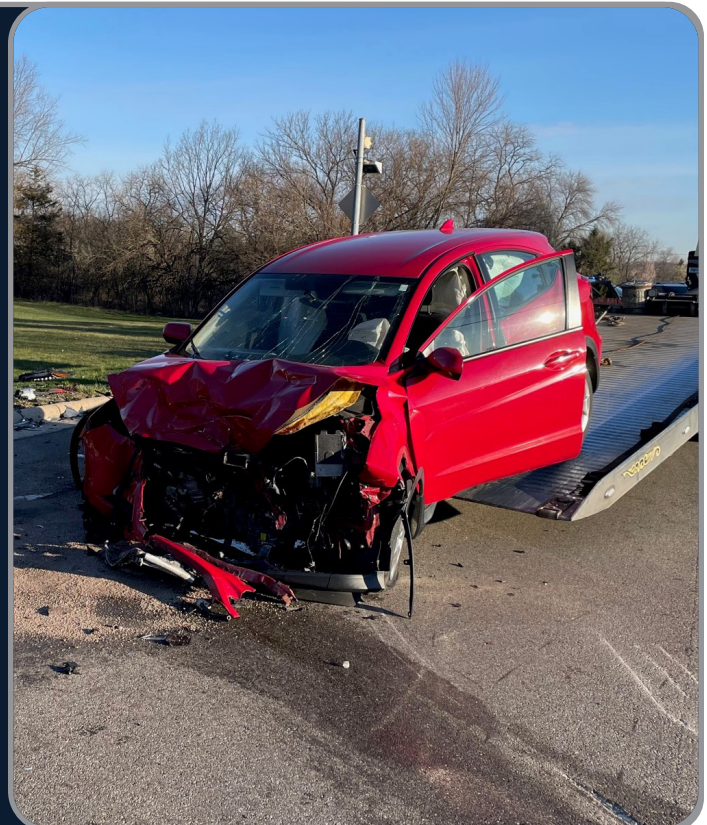


On 3/24/24 @ 10:00 hours, crews responded to State Route 73 and Township Line Road for a reported vehicle accident with injuries. Upon arrival, crews found a truck and a car involved in a crash with the truck rolled onto its side, off road. Crews extricated one entrapped person and transported two patients to Atrium Medical Center. Crews secured the site of hazards and released the scene to Clearcreek PD.

On 3/24/24 @ 05:12 hours, crews responded to a nursing home for a reported cardiac arrest. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Clearcreek PD.



On 3/21/24 @ 08:20 hours, crews responded to Edinburgh Drive and South Main Street for a reported vehicle accident with injuries. Upon arrival, crews found two cars involved in a crash. Crews transported two patients to Atrium Medical Center. Crews applied absorbents to mitigate fluid on the roadway. After securing the site of hazards, crews released the scene to Springboro PD.
