On 3/14/23, Lieutenant Naveed Khan and Firefighter / Paramedics Jordan Holbrook and Jimmy Powell responded to a residence for an obstetric emergency. Upon arrival, they found Mercy Chong in active labor with the baby breech. A breech birth happens when the baby is positioned either buttocks or feet down instead of headfirst, presenting severe risks to both mother and child. With no time to spare, our medics assisted the mother in delivering the baby. The crew then attended to the infant and mother and transported both to Kettering Health Washington Township.

At the April 10<sup>th</sup> Clearcreek Township Trustee Meeting, Traci Gabbard, Clinical Nurse Manager for Kettering Health, presented Jordan and Jimmy with the Stork Pin to honor these gentlemen. Naveed had to respond to an emergency and was unable to attend the presentation; however, he received his pin later that evening.



Additionally, the Chong family offered their gratitude for keeping their family safe. The baby's older siblings presented our medics with a hand-made card and a toy truck as a "thank-you" for caring for their baby brother. We are immensely proud of Lieutenant Khan and Firefighter / Paramedics Holbrook, and Powell. Keep up the excellent work, gentlemen!





Meet Firefighter/EMT Alex Becker who joined our family in January 2023. He earned his Fire and EMS certifications from Sinclair Community College. Alex holds rescue certifications in Vehicle and Machine, Swift Water, Confined Space, Trench, Structural Collapse, and Grain Bin. 




### Total Alarms


# Alarms by Service Type



### Average Response Times



# SIGNIFICANT RESPONSES

On 4/3/23 @ 13:31 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest. Crews initiated ALS procedures and transported the patient to Kettering Health Main Campus.

On 4/3/23 @ 16:06 hours, crews responded to Pioneer Boulevard for a reported fire alarm. Upon arrival, crews found a pressure device ruptured, sending pieces of manufactured plastic into a sprinkler head, causing the sprinkler to activate. One person was injured due to the incident, but the patient refused care. The occupant contacted the sprinkler company for repairs. Crews placed the location on fire watch until technicians repaired the suppression system.

On 4/3/23 @ 16:42 hours, crews responded to a residence for a reported non-breather. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Clearcreek PD.

On 4/5/23 @ 09:22 hours, crews responded to a residence for a reported non-breather. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Clearcreek PD.

On 4/7/23 @ 14:04 hours, crews responded to East Pekin Road for a reported building fire. Upon arrival crews found a single-story residence with fire showing from the front. All occupants evacuated the building. Medic crews transported one patient to Atrium Medical Center. Using a handline, crews knocked the fire down from the exterior before entering the structure to extinguish the fire. Once extinguished, crews performed overhaul and checked for heat signatures. Finding no further hazards, crews secured the building. Franklin Township, Lebanon, and Turtlecreek Township provided mutual aid assistance. The estimated property damage from fire is \$105,000.



On 4/8/23 @ 02:32 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews found a patient unresponsive with law enforcement performing CPR. Crews initiated ALS procedures with no response from the patient. Medical Control provided a field termination of resuscitation efforts order. Crews contacted the coroner and released the scene to Springboro PD.

On 4/12/23 @ 19:24 hours, crews responded to Arbor Hills for a reported building fire. Upon arrival, crews found a residence with fire showing from the back of the house, no occupants were at the residence at the time. Crews established a primary and secondary water supply to extinguish the fire. Additional crews performed interior attack and overhaul. Once extinguished, crews checked for heat signatures and secured the building. Two firefighters sustained injuries during the incident and were transported to Miami Valley Hospital South. Wayne Township, Miami Valley Fire District, Washington Township, and Joint Emergency Medical Services provided mutual aid assistance. The estimated property damage from fire is \$237,000.

On 4/17/23 @ 08:23 hours, crews responded to East Manor Drive for a reported building fire. Upon arrival, crews found a residential building with nothing showing. The homeowner stated that a candle caught items on a bookshelf on fire and was put out using an extinguisher. Upon investigation, crews found smoke damage present, along with a burnt bookshelf and drywall. Crews checked for heat signatures and extension into the attic. Finding no additional hazards, crews returned to service. The estimated damage from fire is \$7,000.



On 4/18/22 @ 10:44 hours, crews responded to West Central Avenue for a reported passenger vehicle fire. Upon arrival, crews found a single vehicle on fire with multiple vehicles exposed. Crews extinguished the fire using a handline. Crews secured the site of hazards and released the scene to Springboro PD. The estimated property damage from fire is \$8,000.



On 4/18/22 @ 19:57 hours, crews responded to West Central and Clearcreek Franklin Road for a reported vehicle accident with injuries. Upon arrival, crews found two vehicles involved in a crash with one car on its top. Crews took position to shield the scene and stabilized the flipped vehicle to extricate one passenger. Crews transported two patients to Kettering Health Main Campus. Crews cleared the site of hazards and released the scene to Springboro PD. Franklin Fire Department provided mutual aid assistance.



On 4/27/23 @ 13:49 hours, crews responded to Pennyroyal Road for a reported building fire. Upon arrival, crews found a detached garage fully involved in fire. Crews used a handline to extinguish the fire. Finding no extension to the main building, crews performed salvage and overhaul. No injuries were reported during this incident. The estimated property loss due to fire is \$15,000.



On 4/25/23 @ 03:01 hours, crews responded to Kesling Drive for a reported building fire. Upon arrival, crews found a working fire in the garage of a single-story house, which extended into the attic and threatened to spread into the residence. All occupants evacuated the building. Crews extinguished the fire using a handline and checked for heat signatures throughout the residence. Crews performed salvage and overhaul. No injuries were reported during this incident. Miami Valley Fire District, the City of Franklin, and Joint Emergency Medical Services provided mutual aid assistance. The estimated property loss due to fire is \$263,000.



On 4/23/23 @ 04:04 hours, crews responded to Old State Route 122 for a reported passenger vehicle fire. Upon arrival, crews found a single vehicle off the roadway, fully engulfed in flames. The driver evacuated the vehicle before crews arrived onscene. Medic crews transported the driver to Atrium Medical Center. Crews extinguished the fire using a handline. After securing the site of hazards, crews released the scene to Clearcreek PD. The estimated property loss due to fire is \$22,000.
