The Clearcreek Township Trustees met in regular session with the following members present: Mr. Lamb and Dr. McDonald.

Mr. Lamb moved to approve the regular minutes on July 22, 2009 at 6:30 PM. The motion was seconded by Dr. McDonald and upon roll call the vote was as follows: Mr. Lamb-yea; Dr. McDonald-yea: Mr. Wade-absent.

Mr. Lamb moved to approve the recommendation of the Fiscal Officer to accept Craig Colston as permanent part-time status as assistant to the Fiscal Officer and receive the appropriate pay increase from \$20.00 per hour to \$20.60 per hour effective July 31, 2009. The motion was seconded by Dr. McDonald and upon roll call the vote was as follows: Mr. Lamb-yea; Dr. McDonald-yea; Mr. Wade-absent.

Mrs. Oda introduced Keith McFarland, Assistant Vice President and portfolio manager from Fifth Third Bank, who gave a brief description on the new investment procedures the Clearcreek Township Fiscal Officer will be adopting. Further, an investment policy will be brought before the Trustees at a later date.

Mr. Lamb moved to adopt Resolution #3567 amending the permanent appropriations resolution with supplemental appropriations. The motion was seconded by Dr. McDonald and upon roll call the vote was as follows: Mr. Lamb-yea; Dr. McDonald-yea; Mr. Wade-absent. Ms. Anita Carroll, Director of Franklin-Springboro Public Library discussed the current estimated library budget for 2009 and requested the Clearcreek Township Trustees consider a one-time contribution of \$50,000.00 to match the amount donated by the City of Springboro.

Mr. Lamb moved to adopt Resolution #3568 accepting a donation from David F. Tritch for the Clearcreek Fire District. The motion was seconded by Dr. McDonald and upon roll call the vote was as follows: Mr. Lamb-yea; Dr. McDonald-yea; Mr. Wade-absent.

Mr. Lamb moved to approve the recommendation of the Assistant Fire Chief to hire Matthew Spears as a probationary part-time Firefighter/EMT effective August 23, 2009. The motion was seconded by Dr. McDonald and upon roll call the vote was as follows: Mr. Lamb-yea; Dr. McDonald-yea; Mr. Wadeabsent. Dr. McDonald then administered the oath of office to the above named employee.

Mr. Lamb moved to adopt Resolution #3569 authorizing the Township Administrator to enter into a service agreement for software maintenance programs.
