Mr. Wade opened the meeting and led in the Pledge of Allegiance. Mr. Muterspaw moved to approve the meeting minutes of December 27, 2018. The motion was seconded by Mr. Gabbard and upon roll call the vote was as follows: Mr. Muterspawyea; Mr. Gabbard-yea; and Mr. Wade-yea. Mr. Carolus, Fiscal Officer, reported that the General Fund balance as of December 31st, 2018 was 1.776 million dollars. Mr. Gabbard moved to approve warrants #28501 through #28565 and electronic fund transfers #4-2019. The motion was seconded by Mr. Muterspaw and upon roll call the vote was as follows: Mr. Gabbard-yea; Mr. Muterspaw-yea; and Mr. Wade-yea. Mr. Muterspaw moved to make a conditional offer of probationary employment as a fulltime police officer to Eric Peabody at a probationary rate of pay of \$29.13 per hour, effective January 28th, 2019, and place Officer Peabody on a one year probationary status. Mr. Gabbard seconded the motion and upon roll call the vote was as follows: Mr. Muterspawyea; Mr. Gabbard-yea; and Mr. Wade-yea. Mr. Wade administered the Oath of Office to Mr. Peabody. Mr. Clark, Township Administrator, requested that the Board authorize sick time sell back for all eligible personnel and to allow the Fiscal Officer to make such payment on the March 8, 2019 pay date. Mr. Gabbard moved to authorize the payment. The motion was seconded by Mr. Muterspaw and upon roll call the vote was as follows: Mr. Gabbard-yea; Mr. Muterspaw-yea; and Mr. Wade-yea. Mr. Muterspaw moved to authorize the replacement of a furnace at Fire Station 21 for a proposed cost of \$3,747 with the work to be executed by Watkins Mechanical. Mr. Steven Agenbroad, District Fire Chief, asked that the Board authorize the replacement of the Self Contained Breathing Apparatus (SCBA) Fit Test machine. The \$11,300 cost of the machine will be shared with the Wayne Township Fire Department paying half the purchase price along with half the annual maintenance. Mr. Gabbard moved to authorize the replacement of the SCBA Fit Machine at a cost of \$5,650. The motion was seconded by Mr. Muterspaw and upon roll call the vote was as follows: Mr. Gabbard-yea; Mr. Muterspawyea; and Mr. Wade-yea. Mr. Muterspaw moved to begin the examination process to establish an eligibility list for filling three budgeted, but unfilled, Firefighter/Paramedic/Emergency Medical Technician positions. The motion was seconded by Mr. Gabbard and upon roll call the vote was as follows: Mr. Muterspaw-yea; Mr. Gabbard-yea; and Mr. Wade-yea. Mr. Gabbard moved to authorize the Township's participation in the Warren County Engineer's Office 2019 repaying program at an estimated cost of \$430,000. The motion was
