#### Significant Responses

On 6/1/25 at 12:58 hours, crews responded to a residence for a reported gunshot wound. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Clearcreek PD.



On 6/15/25 at 09:45 hours, crews responded to Bunnell Hill Road for a reported motor vehicle accident with injuries. Upon arrival, crews found semi-trailer into a house. The driver evacuated the vehicle and reported no injuries. Crews mitigated roadway hazards and released the scene to Clearcreek PD.



On 6/21/25 at 12:42 hours, crews responded to a residence for a reported choking. Upon arrival, crews found a patient in severe respiratory distress and became unresponsive. Crews initiated ALS procedures and transported the patient to Miami Valley Hospital Austin Boulevard Emergency Center. On 6/21/28 at 21:00 hours, crews responded to a residence for a reported choking. Upon arrival, crews found a patient unresponsive with shallow breathing and weak pulse. Family members presented crews with a valid DNR. Crews remained on scene with Hospice staff until the patient passed. Crews contacted the coroner and released the scene to Clearcreek PD.

On 6/25/25 at 13:43 hours, crews responded mutual aid into Wayne Township for a reported downed electrical wire. Upon arrival, crews found a semi-trailer with utility wires on the truck from a downed utility pole. The driver reported no injuries. Crews tested the wire and found active electrical current. Crews contacted AES Ohio and blocked the scene until technicians arrived to remove the live wire. Finding no additional hazards, crews returned to service.



On 6/28/25 at 01:20 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest with CPR in progress. Crews initiated ALS procedures and transported the patient to Kettering Health Miamisburg.
