On June 27, 2025, Corporal Knobbe responded to a residence in the 1000 block of North Wood Creek Drive, to serve an arrest warrant. Upon arrival, officers served the warrant, and a male resident was transported to the Warren County Jail.

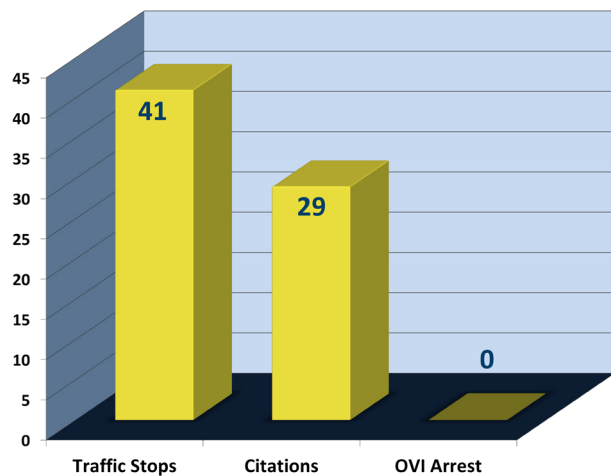
On June 27, 2025, Officer Bronnenberg was on routine patrol of East Lytle Five Points Road when he observed a motorcycle whose speed was recorded at 94 Miles Per Hour in the posted 50 Mile Per Hour zone. Upon attempting to stop the motorcycle, the motorist failed to comply with the lawful police order to stop. The motorist continued to flee officers until he came to a stop on Elm Tree Road. Upon investigation, the male motorist was charged with Speeding, Failure to Comply with Order or Signal of a Police Officer, and Operating a Motorcycle without a Valid Motorcycle License.

On June 16, 2025, Sergeant Sweet, Corporal Knobbe, and Officers Knobbe and Hall, responded to a report of Domestic Violence at a residence in the 1000 block of Elm Brook Trail. Upon arrival, officers met with a female victim that stated that her live-in boyfriend had pushed her and choked her during an argument. Upon further investigation, the male was charged with Domestic Violence.

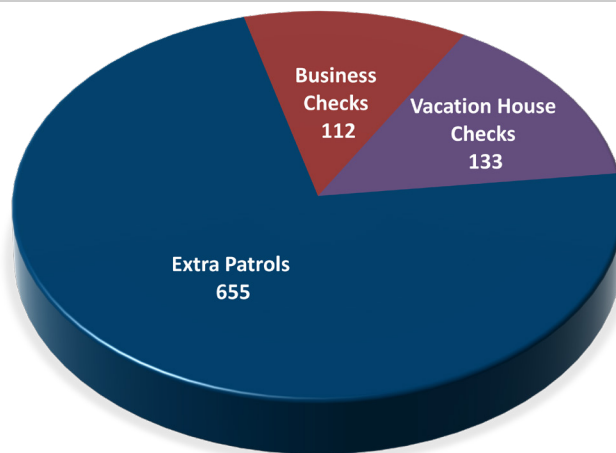
On June 8, 2025, Corporals Morgan and Blaha, and Officer Hall, responded to a residence in the 1400 block of Meadow Woods Court, for a 911 call. Dispatch advised responding officers that a female was screaming "get away from me" to a male while she was on the phone with the 911 operator. Upon arrival, officers began their investigation, and it was found that the male at the residence had an active warrant for his arrest. The male was charged with Menacing, as a result of this incident, and was arrested for the active warrant to include the charges of Strangulation, Burglary, Motor Vehicle Theft, Theft, Criminal Trespass, Assault, Kidnapping, and Obstructing Justice. The warrant charges stemmed from a previous incident in Clearcreek Township.

On June 6, 2025, Corporal Knobbe and Officer Bronnenberg responded to a residence in the 1400 block of Music Place for a report of a Domestic Dispute. Upon arrival, officer met with the male complainant at the residence who stated he and his live-in girl friend had been involved in an argument and that she had punched him in the face. Upon further investigation, the female participant was charged with Domestic Violence.

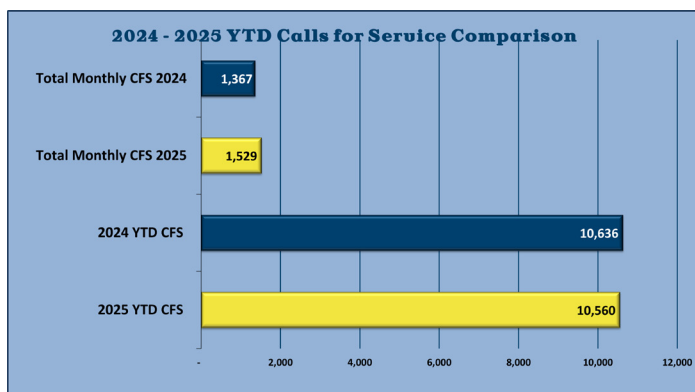

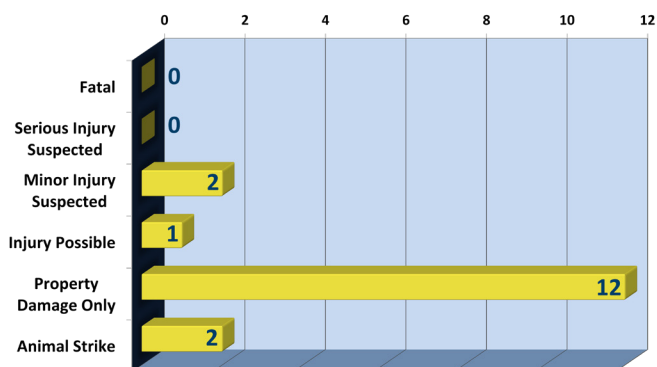
