As a Sergeant with the U.S. Army Reserves, Firefighter Abbie Muterspaw received a deployment assignment in autumn 2024. Having recently returned, we welcomed her home with open arms and asked about her time serving our country. Here is what she had to say:

I was deployed from October 2024 to August 2025 to western Iraq as a part of the 932nd Forward Resuscitative Surgical Detachment (FRSD). The role of an FRSD is to perform damage control resuscitation and surgery on critical patients in austere environments. FRSDs are also capable of "FRO" missions (formerly known as GHOST, Golden Hour Offset Surgical Team) in which they offer mobile care, closely following missions and setting up surgical operations on the fly. I served as NCOIC of the Advanced Trauma Life Support section and was a recipient of the Army Commendation Medal with C device. On International Firefighters' Day, I flew an American Flag over our facility in honor of Clearcreek Fire District, that will be placed in a shadow box. I'm so thankful to my Clearcreek family for supporting me on my journey and am happy to be back!

We are extraordinarily proud and honored to have Abbie among our ranks. Thank you, Abbie, for your commitment to Country and Community, and welcome home!

Congratulations to Firefighters Dylan Stickney and Cody Bohachek for completing the requirements to operate as an Aerial Tower Operator.

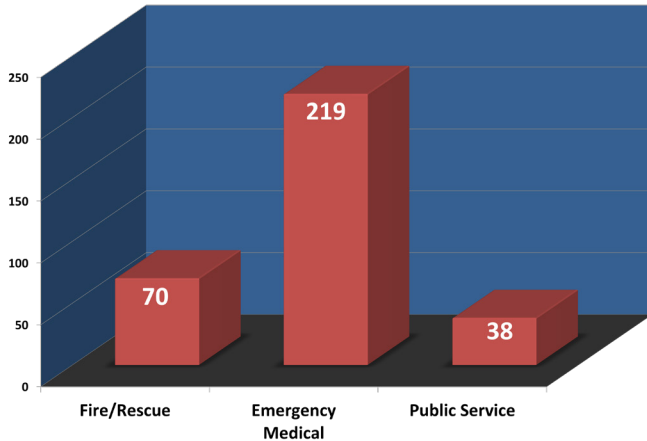

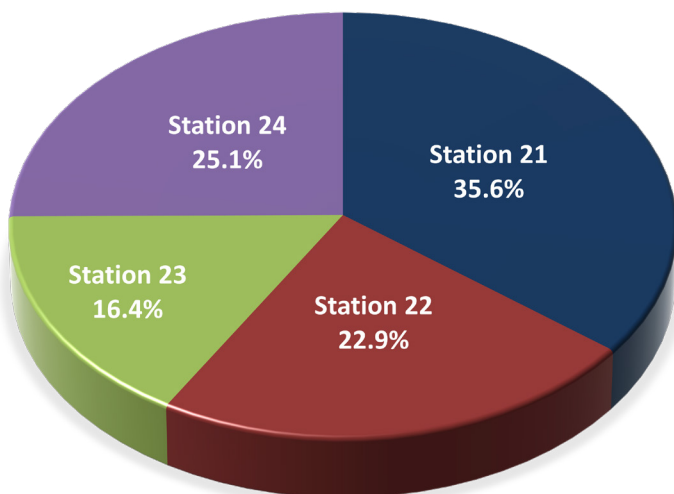
Alarms by Service Type

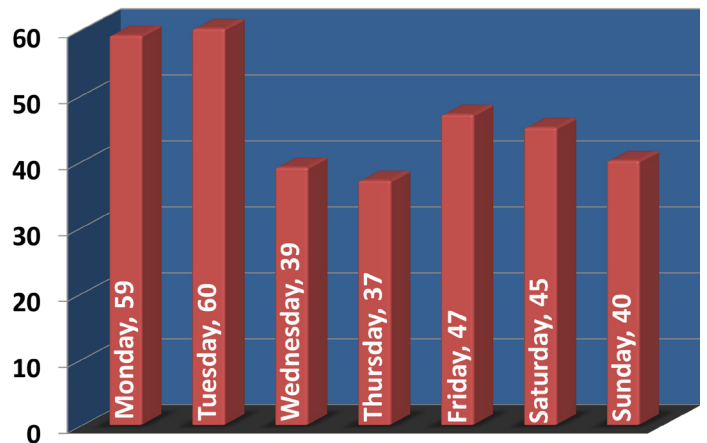
Response Percentages

Significant Responses

On 9/9/25 at 17:19 hours, crews responded to Utica Road for a reported motor vehicle accident with injuries. Upon arrival, crews found a single car on its top on the roadway with all occupants out of the vehicle. Crews transported one patient to Atrium Medical Center. After stabilizing the car and mitigating roadway hazards, crews released the scene to Clearcreek PD.



On 9/13/25 at 08:47 hours, crews responded to a residence for a reported fall. Upon arrival, crews found a patient in cardiac arrest. Crews initiated ALS procedures, with no response from the patient. Medical control provided a field termination of resuscitation efforts order. Crews contacted the coroner and released the scene to Springboro PD.

On 9/14/25 at 04:15 hours, crews responded mutual aid into Wayne Township for a reported motor vehicle accident with injuries. Upon arrival, crews found a vehicle into a house with Wayne Township crews and the building inspector on-site. A vehicle knocked out one garage wall and moved a propane cylinder by several feet. All utilities were shut off, the building evacuated, and the vehicle towed. Crews assisted with clearing the area and constructing shoring to stabilize the garage.

On 9/16/25 at 18:48 hours, crews responded to Utica Road for a reported motor vehicle accident with injuries. Upon arrival, crews found a pickup truck off the roadway with all occupants out of the vehicle. Crews secured the truck and mitigated roadway hazards before releasing the scene to Clearcreek PD.



On 9/19/25 at 00:11 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews determined that the patient was DOA. Crews contacted the coroner and released the scene to Springboro PD.

On 9/28/25 at 17:29 hours, crews responded to a residence for a reported fall. Upon arrival, crews found a patient with lower extremity paralysis due to a fall. Crews initiated ALS procedures and transferred patient care to CareFlight.
