EMS Supervisors completed competency training on Spinal Motion Restriction and splinting.

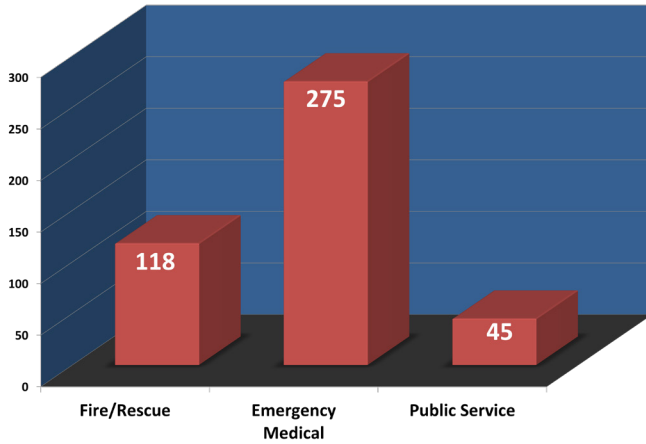

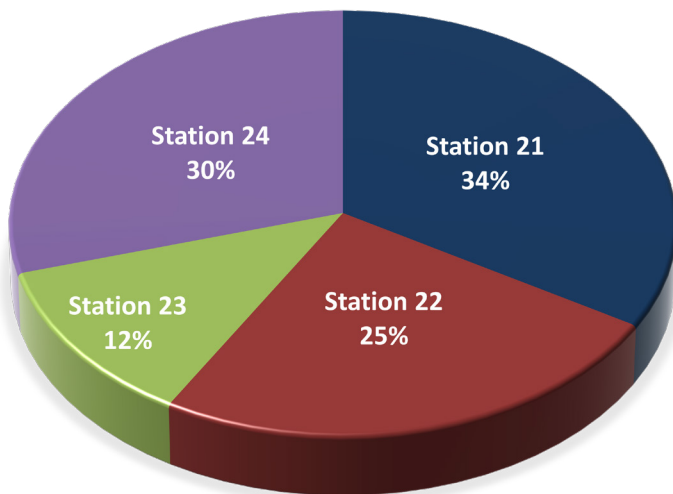
Alarms by Service Type

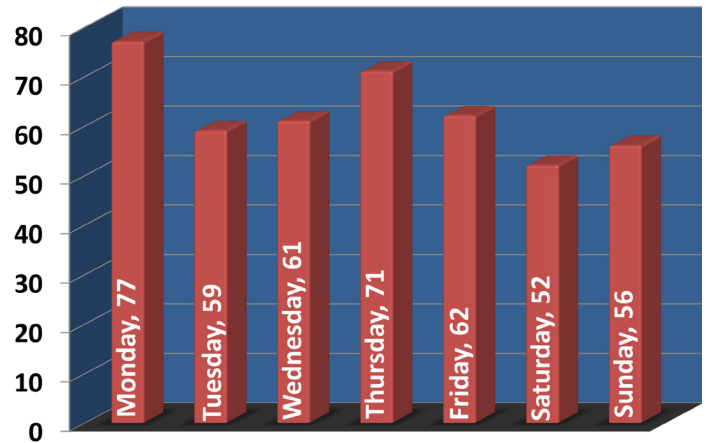
Response Percentages

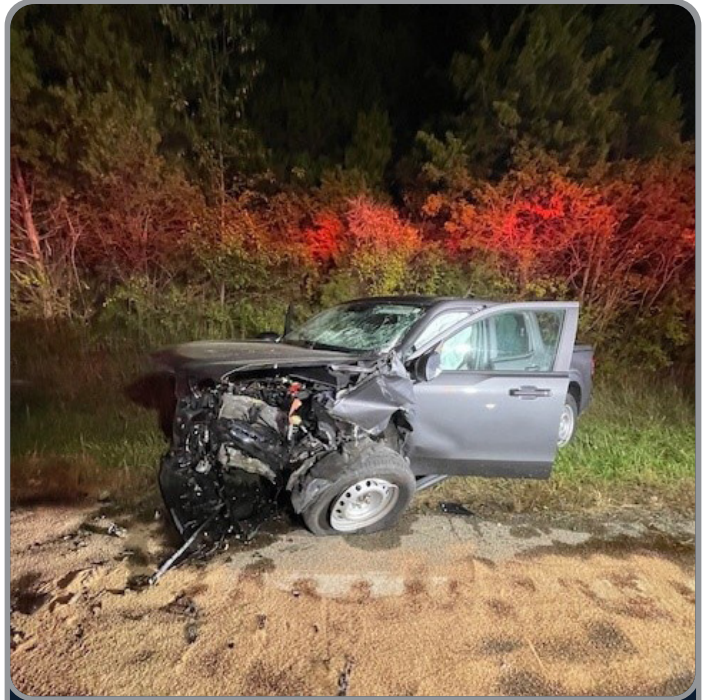

Significant Responses



On 10/4/25 at 11:44 hours, crews responded to a residence for a reported passenger vehicle fire. Upon arrival, crews found a car fully involved in fire near a barn. The vehicle owner stated that the car ignited inside the barn and that they were able to push it out of the structure. Crews extinguished the fire using foam and water. The estimated property loss due to fire is \$25,700.



On 10/12/25 at 19:56 hours, crews responded mutual aid into Wayne Township for a reported motor vehicle accident with injuries. Upon arrival, crews found two vehicles involved in a crash with entrapment. Crews assisted with extrication efforts. Crews transported one patient to Kettering Health Main Campus, another to Miami Valley Hospital Main Campus, and transferred care of a third patient to UC Air Care.



On 10/14/25 at 13:49 hours, crews responded to West Central Avenue for a reported motor vehicle accident with injuries. Upon arrival, crews found two vehicles involved in a crash. Crews transported one patient to Kettering Health Franklin. Crews stabilized the vehicles and released the scene to Springboro PD.



On 10/14/25 at 20:14 hours, crews responded to North State Route 48 for a reported motor vehicle accident with injuries. Upon arrival, crews found a single vehicle off the roadway into a ditch. The driver denied any injury. Crews stabilized the vehicle and released the scene to Clearcreek PD.



On 10/14/25 at 17:22 hours, crews responded to Red Lion Five Points Road for a reported motor vehicle accident with injuries. Upon arrival, crews found three vehicles involved in a crash, with one vehicle off the roadway on its side. Crews transported one patient to Kettering Health Franklin and evaluated another patient who refused treatment and transport. Crews stabilized the vehicles and released the scene to Clearcreek PD.



On 10/17/25 at 18:34 hours, crews responded mutual aid into Wayne Township for a reported motor vehicle accident with injuries. Upon arrival, crews found two vehicles involved in a crash with one patient extricated. Crews assisted with patient care and transferred the patient to CareFlight.



On 10/20/25 at 22:19 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Springboro PD.

On 10/23/25 at 10:24 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Springboro PD.

On 10/23/25 at 12:18 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest with CPR in progress. Crews initiated ALS procedures and transported the patient to Miami Valley Hospital South.

On 10/26/25 at 16:28 hours, crews responded to a business for a reported structure fire. Upon arrival, crews found a two-story office building with nothing showing. Investigation revealed a burning odor and smoke around the elevator. Crews shut off power to the elevator and ventilated the building. Finding no additional hazards, crews released the scene to building maintenance.

On 10/26/25 at 21:12 hours, crews responded to Township Line Road for a reported motor vehicle accident with injuries. Upon arrival, crews found a vehicle rolled over on its side with an occupant entrapped and fluids on the roadway. Crews stabilized the vehicle and extricated the driver. Crews initiated ALS procedure and transferred the patient to Careflight. After mitigating roadway hazards, crews released the scene to Clearcreek PD.



On 10/27/25 at 10:44 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Springboro PD.

On 10/27/25 at 12:55 hours, crews responded mutual aid into Wayne Township for a reported shooting with multiple victims. Crews initially staged until law enforcement secured the scene. Upon arrival, crews found one patient who sustained a gunshot wound. Crews initiated ALS procedures and transported the patient to Kettering Health Main Campus.



On 10/29/25 at 11:45 hours, crews responded mutual aid into Carlisle for a reported building fire. Upon arrival, crews found a detached garage fully involved in fire with extension onto the roof of the adjacent residence. Crews assisted with extinguishment and overhaul until released by command.
