AEngaging Our Community

Clearcreek Township Police Officers joined other officers and agencies in Warren County for an annual county wide training. This year's topic was on driving and high-risk traffic stops. This training helps train the Warren County law enforcement agencies on the same tactics to better assist each other on scene.



Significant Activity

On October 24, 2025, Officer Horwarth received a call from the Beavercreek Police Department in reference to a possible kidnapping of a male resident of Clearcreek Township. Beavercreek police had stopped a vehicle, in their jurisdiction, with three occupants. During the investigation, it was alleged that two juvenile occupants of the vehicle forced the third occupant into their vehicle at his residence. Two juveniles were charged with Kidnapping as a result of the incident.

On October 23, 2025, Sergeant Sweet and Officer Horwarth responded to a residence in the 6000 block of North State Route 48, for a report of Domestic Violence. A female at the residence stated that her husband had grabbed her and pushed her against the wall during an argument. Upon investigation, the male participant in the argument was charged with two counts of Domestic Violence.

On October 14, 2025, Officers Horwarth and Hall responded to a report of a single vehicle traffic crash at the intersection of Red Lion Five Point Road and Bull Run Court. Upon arrival, officers observed a crashed UTV on its side, off the roadway. Officers contacted the female driver of the UTV who admitted that she had been consuming alcohol. Officers attempted to have the female perform field sobriety tests; but she became more disorderly. Officers advised the motorist that she was under arrest for OVI and the female began physically resisting officers. The female was transported to a local hospital where she continued to be combative to officers and hospital staff. Upon investigation, the female was charged with OVI, Disorderly Conduct, Operation without being in Reasonable Control, No Vehicle Registration, and Resisting Arrest.


On October 12, 2025, Sergeant Cordero and Officer D. Williams met with a male at the Clearcreek Township Police Department for a report of a family dispute. The male juvenile stated to officers that his father had been yelling at him, and was aggressive towards him, at his residence in the 7000 block of Bunnell Hill Road. Officers spoke with the parents about the incident, and it was alleged by the parents that the juvenile was being unruly and had made threats to harm both the mother and father. Upon investigation, the male juvenile was charged with Domestic Violence.

On October 11, 2025, Sergeant Sweet was patrolling the area of East State Route 73, and Country Brook Court, when he observed a vehicle in front of him drive into the opposing lane of traffic and other traffic infractions. Officers conducted a traffic stop of the vehicle and the male driver of the vehicle stated that he had consumed about 4 to 5 beers while attending an event. A juvenile passenger was also in the vehicle. Officers requested that the male motorist perform field sobriety tests to which the male stated he would not take the tests because he would fail them. The male was charged with OVI, Driving in Marked Lanes, and Endangering Children. The male was found to have a BAC of .134.


On October 7, 2025, Officer Hall was performing a business check at the Marathon Gas Station, in Red Lion, when he noticed a vehicle that had a male passenger with their head down, not moving. Officer Hall performed a welfare check on the motorist and was informed by the male that he was ok and was tired from work. Officers noticed an open container of an alcoholic beverage in the male's vehicle while speaking with him. Officers requested the motorist to perform field sobriety tests, and the male complied, showing no signs of impairment. Upon investigation, the male was issued a summons for Open Container of Beer or Liquor Prohibited in a Motor Vehicle.

On October 6, 2025, Officer Hall was dispatched to the area of West State Route 73 and Red Lion Five Points Road for a vehicle driving recklessly. Officers located a vehicle in the area of East State Route 73 and Bunnell Hill Road where they observed several marked lanes violations. Officers conducted a traffic stop on the vehicle and, while stopping, it almost struck a telephone pole. Upon making contact with the female driver, officers noticed she was disoriented and had slurred speech. The female also had THC gummies in the vehicle. The female motorist performed field sobriety tests, and upon further investigation, was charged with OVI, Driving in Marked Lanes, and Operating a Motor Vehicle without a Valid License.


