
During November 2025, several fire watches were issued and managed by personnel for Quality Inn on Sharts Road.


Alarms by Service Type

Response Percentages





Significant Responses

On 11/4/25 at 21:48 hours, crews responded to a nursing home for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest with CPR in progress. Crews initiated ALS procedures with no response from the patient. Medical Control provided a field termination of resuscitation efforts order. Crews contacted the coroner and released the scene to Springboro PD.

On 11/4/25 at 19:03 hours, crews responded mutual aid in Wayne Township for a reported building fire. Upon arrival, crews found a trailer fully engulfed in fire with Wayne Township crews on-scene. Crews assisted with extinguishing the fire and mitigating hot spots until they were released by command.




On 11/6/25 at 07:25 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews determined that the patient was DOA. Crews contacted the coroner and released the scene to Springboro PD.

On 11/11/25 at 19:32 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest. Crews initiated ALS procedures with no response from the patient. Medical Control provided a field termination of resuscitation efforts order. Crews contacted the coroner and released the scene to Clearcreek PD.

On 11/15/25 at 11:32 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest with CPR in progress. Crews initiated ALS procedures with no response from the patient. Medical control provided a field termination of resuscitation efforts order. Crews contacted the coroner and released the scene to Springboro PD.

On 11/16/25 at 01:15 hours, crews responded to State Route 48 and Bunnell Hill Road for a reported motor vehicle accident with injuries. Upon arrival, crews found a vehicle rolled over on its top with all occupants out of the vehicle. Crews transported one patient to Kettering Health Franklin and another to Dayton Children's Hospital South Campus. Finding no additional hazards, crews released the scene to Clearcreek PD.

On 11/26/25 at 07:09 hours, crews responded to a residence for a reported downed tree. Upon arrival, crews found a tree fallen into the building with a visible hole in the roof. Interior investigation showed the ceiling in a bedroom collapsed. Further evaluation showed damaged trusses in the attic. The estimated property damage is \$20,000.





Fire and Rescue Training

On-duty crews completed live burn training on November 12, 13, and 14 at the Warren County Career Center. Over 40 pallets and more than 20 bales of straw were used to set 28 individual fires for each training scenario. Live fire training is essential for firefighters because it exposes them to real heat and smoke conditions that cannot be replicated in simulations. It helps our firefighters to make decisions under stress, and safely practice critical skills such as hose advancement, extinguishment, search and rescue, ventilation, and overhaul techniques. Overall, live fire training builds confidence, improves firefighter performance, and dramatically enhances safety during actual emergencies.



EMS Training

Crews completed EMS training on Pediatric Toxic Ingestion, EMS Crew Resource Management, and Airborne and Bloodborne Pathogens.

Prevention Training

Fire Inspectors completed continuing education on the Kettering Health Medical Group Primary Care building located at 243 West Central Avenue.

Company Training

Each Station completed professional development training on Cold Weather Operations training to help maintain operational readiness during the upcoming winter months.
