


### Alarms by Service Type



### Average Response Time



#### Significant Responses



On 4/1/25 at 11:29 hours, crews responded mutual aid into Lebanon for a reported structural collapse. Upon arrival, crews found a vehicle crashed into a building. Rescue crews assembled and installed shoring to secure the structure. Crews returned to service after securing the building.





On 4/3/25 at 02:09 hours, crews responded to a residence for a reported structure fire. Upon arrival, crews found a barn on fire and collapsed. Investigation showed no exposure. Crews deployed a handline to extinguish the fire. Miami Valley Fire District provided mutual aid assistance. The estimated property damage from the fire is \$20,000.





On 4/5/25 at 01:26 hours, crews responded to a residence for a reported water problem. Upon arrival, crews found a home flooded with approximately two feet of water. Crews assisted two occupants out of the house and contacted the Red Cross. No injuries were reported during this incident. The estimated property damage due to flooding is \$130,000.



On 4/14/25 at 11:08 hours, crews responded mutual aid into Turtlecreek Township for a reported vehicle accident with injury. Upon arrival, crews found a pickup truck and dump truck involved in a crash with entrapment in both vehicles. Rescue 21 crews shielded the scene and assisted with extrication. After securing the site of hazards, crews released the scene to Ohio State Patrol and Turtlecreek Township Fire. On 4/14/25 at 14:43 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest with CPR in progress. Crews initiated ALS procedures and transported the patient to Atrium Medical Center.

On 4/16/25 at 00:14 hours, crews responded mutual aid into Franklin for a report building fire. Upon arrival, crews found a single-story residence with active fire. Crews performed fire attack until released by command.



On 4/19/25 at 07:15 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Clearcreek PD.

On 4/20/25 at 08:54 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Springboro PD.

On 4/24/25 at 14:23 hours, crews responded to a business for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest with CPR in progress. Crews initiated ALS procedures and transported the patient to Atrium Medical Center.
