On the Call

Significant Activity

On April 27, 2025, Corporal Knobbe, and officers Schrage and Horwarth, responded to a residence in the 500 block of Hempstead Court, for a report of domestic violence. Upon arrival, the female at the residence stated that her husband had grabbed her around the neck during an argument. The male suspect left the scene prior to officer's arrival. Officers located the male shortly after arrival and charged the male with Domestic Violence and Strangulation.

On April 23, 2025, Sergeant Bates responded to the Warren County Alternative School for a report of a student that was punching at another student. Upon investigation, a student was charged with disorderly conduct.

On April 17, 2025, Sergeant Sweet and Officer Hall were dispatched to a suspicious vehicle in the area of Winding Run Boulevard and Stone Creek Boulevard. Officers located the vehicle and found that it was parked in the middle of the roadway, with a male motorist asleep behind the wheel. Upon contacting the motorist, officers noticed an odor of an alcoholic beverage coming from the male. Upon investigation, the male was charged OVI.

On April 12, 2025, Officer Bronnenberg responded to the Fox Hollow Rodeo for a report of a male that appeared intoxicated and bothering other attendees. Officers contacted the male and advised him the business wanted him to leave the property. Approximately 30 minutes later, the male returned to the property and was charged with Criminal Trespass.

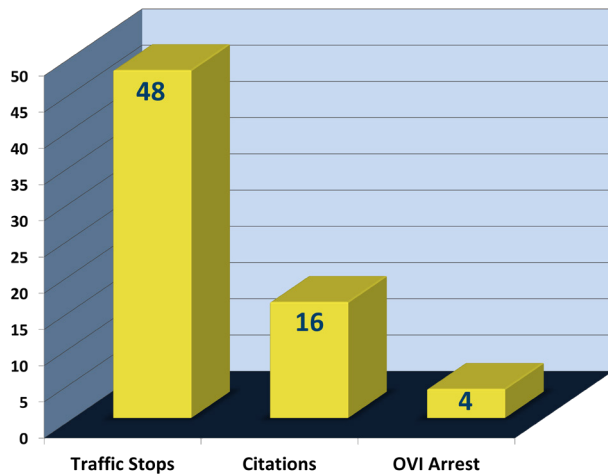
On April 12, 2025, Corporal Knobbe and Officer Horwarth responded to a hit and run crash at the intersection of Bunnell Hill Road and East State Route 73. Witnesses stated a motorist disobeyed a red light and crashed into two other vehicles that had the right-of-way. The motorist that struck the other two vehicles then fled the scene. While officers were on the scene of the crash, they were notified that the vehicle that had fled the crash was disabled on the side of the road near Stone Ridge Drive. Officers made contact with the male motorist of that vehicle, and upon further investigation, the motorist was charged with OVI, Open Container of Beer or Liquor in a Motor Vehicle, and a Red Light Violation.

On April 7, 2025, Officers Hall and Horwarth responded to a residence in the 9000 block of Crooked Creek Drive for a trespassing complaint. The complainant stated that a female relative had shown up to her residence after being told not be on the property. Prior to officers' arrival, the female suspect left in her vehicle and was allegedly intoxicated. Officers observed a vehicle matching the suspect's vehicle description in the area of East Lytle Five Points Road and North State Route 48. A traffic stop was initiated, and contact was made with the female motorist. While speaking with the motorist, officers noticed the female had an odor of an alcoholic beverage and was slurring her speech. Upon further investigation, the female was charged with OVI.

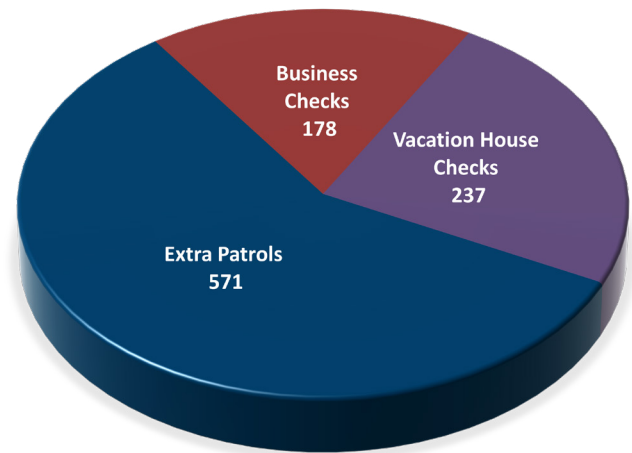
On April 7, 2025, Sergeant Cordero and Officer Bronnenberg responded to the Marathon Gas Station at 3494 North State Route 741, for a burglar alarm. Upon officers' arrival, they observed the front glass door of the business had been broken, and entry had apparently been made. The owner of the business responded and advised officers that many empty cartons of vapes were laying behind the cashier's counter. The owner was able to provide video footage of the incident, but no suspects were known, or found, at that time. At approximately 12:00 hours, Detective Barton, Detective Blaha, Corporal Morgan, and Officer Robinson, received a dispatch that the stepfather of the juvenile suspect was at the business with the suspect to speak with police. Officers arrived on scene, and upon investigation, a male juvenile was charged with Breaking and Entering, Criminal Mischief, and Possession of Criminal Tools.

On April 5, 2025, Sergeant Cordero and Officer Schrage were dispatched to a one car motor vehicle crash in the 5000 block of North State Route 48. The vehicle had struck a utility pole and a fire hydrant. Officers made contact with the male motorist and noticed the odor of an alcoholic beverage and staggered walking. Upon investigation, the male was charged with OVI and Operation without Reasonable Control.

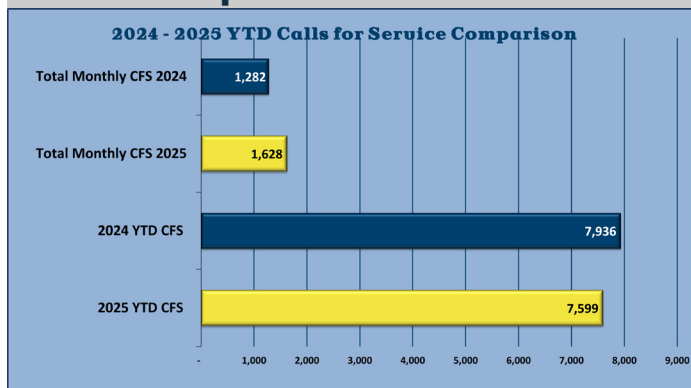

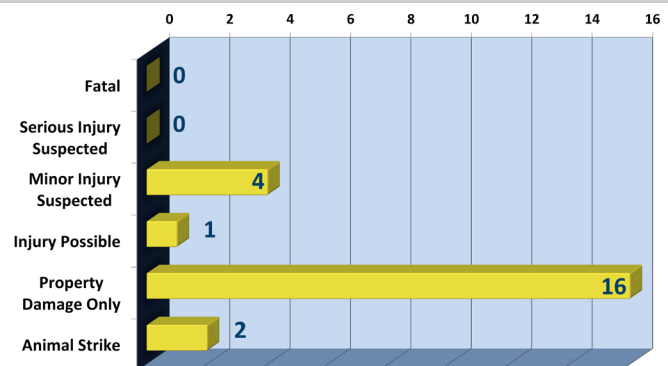

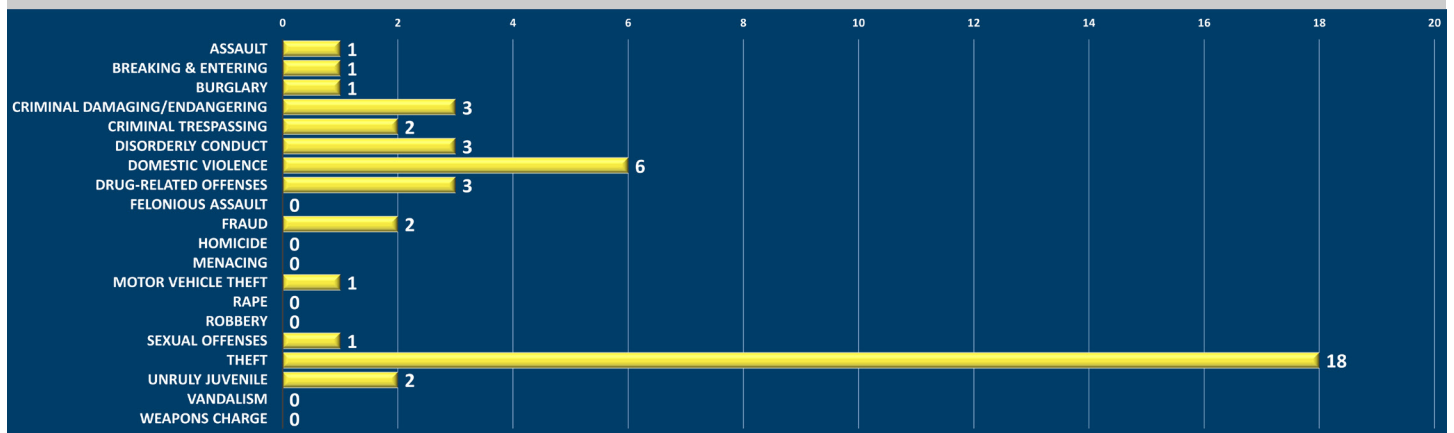
Calls for Service 2024 - 2025 YTD Comparison
