Significant Activity

On July 30, 2025, Sergeant Cordero and Officer Hall responded to a one vehicle crash on State Route 48 in front of Kendrick Moving and Storage. Upon officer's arrival, a female motorist was inside the crashed vehicle attempting to leave the scene. Officers spoke with the motorist, and she stated that she had been consuming alcohol that evening and appeared to be intoxicated. The motorist was transported to the hospital for evaluation and was issued a citation for OVI and Operation of a Motor Vehicle without Reasonable Control.


On July 20, 2025, Sergeant Cordero and Corporal D. Williams responded to a residence in the 3000 block to Township Line Road for a domestic complaint. As officers arrived, a male subject was found on the front porch and told officers "I hit her, take me to jail." Upon investigation it was found that the male had slapped the female in the face during an argument. The male was charged with Domestic Violence.

On July 20, 2025, Sergeant Sweet and Officer Bronnenberg met with a female complainant at the Clearcreek Township Police Department who reported she had just been assaulted by her adult son at her residence in the 3900 block of Springboro Road. She stated he also attempted to smother her with a pillow and put his hand around her neck. Officers obtained an arrest warrant for the male and responded to the residence with the assistance of The Warren County Tactical Response Unit. The male refused commands from officers to come out of the residence. After a few hours, officer's made entry, and the male was taken into custody without incident. The male was charged with Strangulation, Domestic Violence, and Inducing Panic.


On July 13, 2025, Corporal D. Williams and Officer Bronnenberg responded to a residence in the 1700 block of Wandering Stream for a domestic complaint. The female caller stated that her husband had forcefully pushed her out of the way when they were both walking through the same doorway inside the residence. This caused an injury to her ear. Upon investigation, the male was charged with Domestic Violence.

On July 9, 2025, Corporal Morgan was notified that the Ohio State Patrol was in a vehicle pursuit of a motorist that was traveling 154 Miles Per Hour on Interstate 75. The vehicle was being monitored by an OSP aircraft and was seen traveling North Bound on North State Route 741. Officers from the City of Springboro also responded to the area to assist. Officers located the vehicle on North State Route 741 and witnessed numerous hazardous traffic violations. Corporal Morgan attempted to stop the vehicle using his emergency lights and siren. The motorist continued to flee and performed a three-point turn in front of Corporal Morgan's Vehicle. The vehicle then proceeded to drive in the opposite direction as Corporal Morgan attempted to pin the vehicle against the guard rail to end the pursuit. The vehicle eventually drove into a ditch at West Pekin Road and North State Route 741 and was immobilized. The male driver was charged with Failure to Comply with Order or Signal of a Police Officer and other charges from Ohio State Patrol.


