




# FIRE / EMS AVERAGE RESPONSE TIMES IN MINUTES






# Actual (1990 - 2000) and Projected (2001) Requests for Service, based on 5% annual increase

On 6/9/00 @ 18:39 CCFD Fire Crews responded to 625 West Central Ave. @ K-Mart on a report of an electrical fire. Upon arrival crews found a working fire in the rear stock room mezzanine area. The fire was partially contained by the buildings automatic sprinkler system. Fire Crews quickly brought the fire under control, however there was extensive smoke and water damage throughout the rear East side of the store. Crews were on the scene for several hours assisting with salvage ,overhaul, and investigation. Damage was estimated at \$ 101,000.00. The cause of the fire is believed to from a discarded hot object, possibly at cigarette. One CCFD FF/PM was transported to Sycamore Hospital by CCFD EMS Crews suffering from heat exhaustion. The FF/PM was treated and released. Mutual Aid was received from the City of Franklin Fire Department, Miami Township Fire Department, and Wayne Township Fire Departments in extinguishing the Fire. Turtlecreek Township Fire Department provided area station coverage during the incident.

On 6/11/00 @ 20:00 hrs. CCFD Fire Crews responded as a Mutual Aid F.A.S.T. Team into Franklin City at 40 South River Street on a working structure fire.

On 6/12/00 @ 18:09 hrs. CCFD Fire/EMS Crews responded to 120 East Street on a reported Kitchen Fire and explosion. The fire which started on the kitchen stove as a result of unattended cooking was quickly extinguished utilizing a dry chemical fire extinguisher. The occupant was transported to an area hospital by CCFD EMS Crews suffering from minor burns sustained as a result of contact with hot grease while trying to throw the pan with the hot grease out the door in an effort to extinguish the fire. Damage was estimated at \$2,000.00.

On 6/13/00 @ 20:57 CCFD Fire Crews responded to Creekside Drive and Woodside Drive on a dumpster fire.

On 6/14/00 @ 20:25 CCFD Fire Crews responded to Creekside Drive and Woodside Drive on a dumpster fire.

On 6/16/00 @ 17:30 hrs. CCFD Fire Crews responded to 320 West Central Ave. @ Springboro Communications Center on investigation of a lightning strike. As a result of the lightning strike Springboro Communications Center sustained significant lightning damage to their radio system and other electronic hardware. As a result Springboro Communication was unable to dispatch the Fire Department for almost 23 hours ,until damage could be repaired. The Warren County Communications Center provided interim fire department dispatching while Springboro Communications was out of service.

On 6/17/00 @ 10:19 hrs. CCFD Fire Crews responded to 5689 Hathaway Road on a reported barn fire. The fire was first discovered by a passing Clearcreek Township Police Officer who observed smoke coming from the building. Upon arrival crews found a detached concrete block garage shed / well involved in fire. The fire was extinguished a short time later however the garage and contents notably a 1981 Camaro Car were a total loss. The fire was believed to have started by some type of an electrical problem. Mutual Aid was received from Wayne Township Fire Department for water Tanker support as there were no fire hydrants in the immediate vicinity. Damage was estimated at \$ 30,000.00 for the building and contents.

On 6/22/00 CCFD Fire crews responded as a Mutual Aid F.A.S.T. Team into Franklin City at 1357 East Second Street on an odor of burning in a building.

On 7/3/00 @ 23:35 hrs. CCFD Fire Crews responded to 7758 Lemay Street on an Emergency to property, a flooded basement.

On 7/17/00 @ 13:35 hrs. CCFD Fire Crews responded to 257 West Central Ave. @ Rooster's to investigate a reported smell of smoke and gas in the building. Upon arrival crews found high levels of carbon monoxide inside the building as a result of a hot water heater malfunction. The building was evacuated, the water heater shut off, and the building was ventilated. Cinergy was notified. Mutual Aid assistance was provided by the City of Franklin Fire Department and Miami Township Fire Department in managing this incident. Washington Township Fire Department responded mutual aid on a simultaneous EMS Alarm to 9125 North State Route 48.

On 7/20/00 @ 22:20 hrs. CCFD Fire Crews responded to 1348 West State Route 122 on a reported structure fire. Upon arrival crews founded a two story house well involved with fire. Crew initiated an aggressive interior attack and were able to bring the fire under control. This fire required extensive overhaul due to the older construction of the house. Mutual Aid was received from the Franklin Township Fire Department and the City of Lebanon Fire Department. One Clearcreek firefighter was transported to Sycamore Hospital with heat exhaustion and was subsequently treated and released. The State of Ohio Fire Marshall investigated the fire and the cause was determined to be spontaneous combustion of linseed oil soaked cloths disposed of in a plastic bag. Damage was estimated at \$ 140,000.00.

On 7/21/00 @ 11:53 hrs. CCFD Fire / EMS Crews responded to 5474 North State Route 48 on a reported air plane crash. After a through search of the area crews were unable to locate any plane crash. Mutual Aid was received from the following agencies. Warren County Emergency Services Department, City of Lebanon Fire Department, Turtlecreek Township Fire Department, and Miami Valley Hospital Careflight helicopter provided an aerial search. The good intent call was the result of an ten year old that thought they saw a low flying plane go down behind Hidden Valley Fruit Farm and informed their parent who in turn dialed 911.

On 7/25/00 @ 21:45 hrs. CCFD Fire Crews responded to 4005 North State Route 123 on a reported structure fire. Upon arrival crews found an electrical fire in the basement. The fire was quickly extinguished. The fire resulted as result of problem with some electrical wiring in a wall. Mutual Aid assistance was received from the Franklin Township Fire Department. Damage was estimated at \$ 8,000.00.

# 2000 EMS REQUESTS BY DAY OF WEEK




### 2000 EMS CLASSIFICATION BREAKDOWN





Dr. John Granito, the Principal Fire/Rescue Services Consultant was here again 5/30/00 through 6/2/00. A public presentation concerning the summary findings and recommendations is scheduled for Thursday 7/6/00 @ the City of Springboro Council meeting.

-The Fire District received notification of the Year 2000 - 2001 Ohio Department of Public Safety Division of EMS Grant Award. As a result of the District's participation in this process the Fire District was awarded a total of \$ 27,095.00 for funding of EMS related Training and Patient Care Equipment item purchases over the next fiscal year. Specifically, the District was awarded Training funding of \$16,180.00 and Patient Care Equipment funding of \$10,915.00. The EMS grant is awarded annually following an application process Eligible recipients are public EMS Agencies. The grant program is funded through monies collected from seat belt fines.

## July

-The Rural Address Locator Sign Program continued with 7 signs being installed during July, 2000.

-The District completed exterior painting work on all Station #21 exterior doors and frames as well as parking lot resealing and striping work.

-Work continued on updating the Fire Districts Inventory Database for 1999-2000.

-Work continued on updating the Fire District's Box Alarm Mapping System for 1999-2000.

-The Fire District and MMA Consulting Group continued work on the completion a Strategic Analysis and Master Plan for the Clearcreek Fire District. Dr. John Granito, the Principal Fire/Rescue Services Consultant did a public presentation concerning the summary findings and recommendations on Thursday 7/6/00 @ the City of Springboro Council meeting.

-FF/PM Lainhart and other Fire District personnel completed the annual hose testing on all District attack fire hoses as well as the supply hose. Annual hose testing of all fire hoses is a NFPA Standard, as well as an important component of the grading scale used by the I.S.O. Insurance Rating System.

## August

-The Rural Address Locator Sign Program continued with 9 signs being installed during August, 2000.

- Work continued on updating the Fire District's Box Alarm Mapping System for 1999-2000.

- Work continued on outfitting equipping and assembling the Fire District's new Brush Truck.

- Chief Becker attended the Fire Rescue International Exhibits in Dallas, TX on 8/25, 8/26, 8/27, & 8/28. This annual conference, similar to the FDIC, provided an opportunity to exchange ideas with other Fire Service colleagues. It also provided an excellent opportunity to view the latest in Fire /Rescue / EMS equipment & technology innovations. A major goal of this trip was to gather information for several projects identified as target items for the upcoming 2000- 2001 Loeb Foundation Grant Program project and as well as future capital equipment and apparatus.

## September

-The Rural Address Locator Sign Program continued with 1 sign being installed in the month of September 2000.

-Captain Simpson attended a two week Strategic Management of Change Class at the National Fire Academy Emmitsburg Maryland 9/11/99 - 9/22/99. This was the second of four in a series of annual classes in the National Fire Academy's Executive Fire Officer Training Program.

- Work continued on outfitting and equipping the Fire District's new Brush Truck.

October

-Work continued on outfitting and equipping the Fire District's new Brush Truck.

- Work continued on the Career Firefighter Paramedic selection process to find a replacement for FF/PM Gustin. The District hopes to make a recommendation on an individual soon.

-The Fire District hosted Automatic External Defibrillator (AED) and CPR Refresher training for both Clearcreek Township and the City of Springboro Police Departments on 10/10/00, 10/11/00, and 10/12/00.

-The Clearcreek Fire District was evaluated by the Insurance Services Office (ISO) and Commercial Risk Services. The Fire Suppression Rating Schedule (FSRS) is used to rate the communities level of fire protection. This FSRS is applied nationwide and each community is rated using the FSRS. This information is used by insurance companies to determine fire insurance rates . The ISO Evaluation was conducted on 10/17/00,10/19/00, and 10/30/00. The ISO evaluation looks at numerous areas that effect fire protection. Some of which include; Communications Systems, Fire Station Locations, Fire Apparatus and Equipment,Staffing Levels, Training of Personnel, Response, Fire Inspections / Preplanning, Fire Hydrants, and water supply systems.

-The following Fire Prevention activities were performed by the Clearcreek Fire District during October 2000.

- Work continued on the Career Firefighter Paramedic selection process to find a replacement for FF/PM Gustin. As a result of the selection process Part-time Lieutenant Tim Haggard was recommended and accepted the vacant Career Firefighter / Paramedic position. FF/PM Haggard is scheduled to begin work as a Career FF/PM beginning on 12/9/00.


The District researched alternative methods to improve service delivery through changes in staffing and scheduling of part-time personnel.




# 2000 VEHICLE MILEAGE USAGE



# 2000 VEHICLE FUEL USAGE




# AVERAGE COST PER MILE OF OPERATION

## In Conclusion...

The communities of Springboro and Clearcreek Township continue to grow -- thus increasing service demand. The Clearcreek Fire District operates under two dated levies -- a one mil levy from 1981 and a 2.5 mil levy from 1987. A request for additional funds, through a fire levy, was narrowly defeated in November 2000. The Clearcreek Fire District will need to ask the citizens, for a second time, for an increase in funding -- just to keep up with the growth and service demands.

The Clearcreek Fire District has experienced a significant increase in demand for service. In 1990, the Fire District responded to 682 calls for service and in 2000, the Fire District responded to 1579 calls for service. This is over a 127% increase in service request over the past ten years.

The dedication of our personnel and quality of our emergency service delivery is very good. In addition, we expect this to improve with time.
