

Chief's Message





20-Year Service Trend








Potential Property Loss

Budget & Finance

2024 Expenditures



The Fire District's 2024 budget totaled \$24,236,856. This allocated \$11,054,843 for Operations and \$13,182,013 for Capital.

The Operational Budget is predominantly comprised of personnel expenses with the remaining general expenses used to operate, repair, and maintain three fire stations, a fleet of twenty-three apparatus and vehicles, utilities, training, and the purchase of other miscellaneous equipment and supplies. Total Operating expenditures were \$10,297,624 and consisted of three parts: salaries \$6,355,273 (57%), benefits \$3,013,609 (27%), and general operating expenses \$928,742 (8%). Our operating expenditures were 7% under budget.

The Capital Budget is for the acquisition or maintenance of fixed assets such as land, buildings, and equipment. Total Capital expenditures were \$8,241,560. Due to Station 24 being a multi-year construction project, the remaining funds budgeted for 2024 will be carried over into 2025. These expenditures will be reported in the 2025 Annual Report.

Training

All uniformed personnel maintain the following certifications:

- · Firefighter II
- Paramedic or EMT
- Cardiopulmonary Resuscitation
- Advanced Cardiac Life Support

During 2024, employees completed 11,440 hours of documented trainings.

Each Shift Training ranged from one to four hours in length and established a higher level of expectation among all operations personnel.

Some uniformed personnel maintain the following certifications or higher training level:

- Fire Inspector
- Rescue Technician

Continued training and education of our employees is paramount to meet our mission. The 2024 Training Program accomplished the following:

- Fire and EMS Core Competencies Monthly
- Professional Development Training for all officers and acting officers Monthly
- Fire Inspector Training Monthly
- Fire Apparatus Operator Annually
- Aerial Tower Operator Annually
- Hazardous Materials Training Annually
- Complete 16 hours of training each month to maintain Ohio Fire and EMS Certification and ISO standards.

Our firefighters continued to have an exceptional year of professional development through external training offerings. Many firefighters gained additional development through both local and out of state courses as well as online/virtual courses.

The training division approved 89 training requests for external training and/or educational courses.

& District Engagement

Public Education Events

Residents of the community often request our presence at different types of events, including school visits, festivals, and birthday or block parties. We were pleased to continue these events and to collaborate with Clearcreek Elementary on a reading program.

On March 16, 2024, Captain Prass and Lieutenant Carman attended the annual Springboro Business Expo to distribute fire and life safety brochures and answer questions.

On May 11, 2024, Station 21 crews attended Touch A Truck at North Park, hosted by the City of Springboro.

On August 6, 2024, we supported the Clearcreek Police Department in hosting "National Night Out". This annual event, held at Patricia Allyn Park, focuses on bringing the community together for crime prevention and learning more about township services. Firefighters provided tours of the apparatus, answered questions, and provided fire safety information. Firefighters also held a mock auto extrication where they simulated a patient being cut out of a crashed vehicle.

Station 21 hosted approximately 450 people at our annual Open House on October 6, 2024. Activities included a vehicle extrication demonstration, a children's agility course, and a visit from Sparky the Fire Dog. This event is always held on the first Sunday in October.

On November, 22 - 24, 2024, we participated in the Christmas in Springboro Parade and Festival.



Commercial Safety Inspections

The Fire and Life Safety Inspection program focuses on collaborating with business owners to ensure the safety of their employees, customers, and property.


Residential Safety Inspections

Any family wishing to foster or adopt a child must undergo a fire safety inspection in their home. These inspections help identify and eliminate common fire hazards. We provide inhome fire safety inspections for any citizen who requests one.

Pre-Incident Planning

Pre-Incident Plans contain information, such as structural diagrams, allowing crews to anticipate the interior layout of a building prior to performing search and rescue operations. These plans enable the fire officers to make safe and effective tactical decisions.

New Construction Plans Review and Acceptance Testing

We work diligently to ensure that new buildings constructed within the response district are in accordance with governing codes. Our prevention officers work with local building, zoning, and planning commission officials to review and test fire safety equipment during new construction.

Keeping the Promise

Since passing the Fire Levy in 2020, we have been busy fulfilling our promises to our ever-growing community. In our pursuit to provide quality service, we have hired additional personnel, replaced and added to our apparatus fleet, and began construction on Station 24. All these items were promised to the community as part of the 2020 levy campaign.

In 2024, we continued to replace and add to our Fire and EMS fleet with Unit 312. Unit 312 is a 2023 Ford F-550, manufactured by Horton, and equiped for Advanced Life Saving protocol. Currently operating out of Station 21, this unit will operate as Medic 24 upon the completion of Station 24 in the Spring of 2025.





On October 6, 2023, we broke ground on Station 24. The initial discussions for the project began in 2010. After many years of planning and preparation, the project is moving forward. While the cost of this new facility is significantly more than originally planned, we are still able to make it happen as a result of fiscally responsible budgeting practices and the cooperation that exists between Clearcreek Township and the City of Springboro. The station is projected for completion in February of 2025 with operations out of that station beginning shortly after.
