Station 24 Updates

Construction crews applied flashing and fluid air barriers throughout the building in May. They installed joists, bridging, columns, and girders for the Apparatus Bay, Administration Area, and Mezzanine. Electricians began installation with conduits to pole lights and cameras. Additionally, Duke Energy installed the transformer and connected power to the job site. Workers began constructing wood blocking on top of the masonry walls for the roof and completed floor drains in the Training Tower. Ending the month, crews prepared and poured concrete pads for the generator and dumpster. They also began roofing underlayment and interior wall framing for the Administration Area.








Alarms by Service Type

Investigation showed smoke inside the home and a working fire on the stovetop in the kitchen.
