




Total Alarms


Alarms by Service Type


Response Percentages

SIGNIFICANT RESPONSES

On 3/1/23 @ 17:41 hours, crews responded to a residence for a reported non-breather. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Clearcreek PD.

On 3/7/23 @ 08:35 hours, crews responded to a mutual aid call into Lebanon for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest. Crews initiated ALS procedures and transported the patient to Atrium Medical Center.

On 3/7/23 @ 09:58 hours, crews responded to a residence for a reported stroke. Upon arrival, crews found a patient showing stroke symptoms. Crews initiated ALS procedures and transported the patient to Kettering Health Main Campus.


On 3/8/23 @ 12:28 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest with a home care nurse performing CPR. Crews initiated ALS procedures and transported the patient to Atrium Medical Center.

On 3/10/23 @ 17:56 hours, crews responded to West Central Avenue and South Pioneer Boulevard for a reported vehicle accident with injuries. Upon arrival, crews found two vehicles involved in a crash with fluids on the road and Springboro PD extricating an unconscious patient. Crews transported the patient to Kettering Health Main Campus. Crews transported another patient to Kettering Health Franklin. Crews stabilized the vehicles and removed hazardous fluids on the roadway. Finding no additional hazards, crews released the scene to Springboro PD. Joint Emergency Medical Services provided mutual aid assistance.

On 3/14/23 @ 08:19 hours, crews responded to a residence for a reported pregnancy emergency. Upon arrival, crews found the patient in active labor. Crews delivered the baby and transported mother and child to Kettering Health Washington Township.

On 3/22/23 @ 20:41 hours, crews responded to Old State Route 122 for a reported vehicle accident with injuries. Upon arrival, crews found a single car off the roadway. The driver was outside the vehicle and reported no injuries. Crews removed hazardous fluids from the roadway. Finding no additional hazards, crews released the scene to Clearcreek PD.


On 3/26/23 @ 15:27 hours, crews responded to Bunnell Hill Road for a reported building fire. Upon arrival, crews found the remains of a shed actively on fire. Crews pulled a 1-3/4" hose to extinguish the fire and used hand tools to move debris and saturate burning materials. Finding no extension or additional hazards, crews released the scene to Clearcreek PD. The estimated property damage from the fire is \$5,000.



On 3/30/23 @ 07:55 hours, crews responded to North Main Street and Remick Boulevard for a reported vehicle accident with injuries. Upon arrival, crews found two cars involved in a crash. Crews stabilized the vehicles. Crews transported one patient to Kettering Health Washington Township and one patient to Dayton Children's Hospital -South Campus. Crews cleared the site of hazards and released the scene to Springboro PD. Miami Valley Fire District provided mutual aid assistance.



On 3/23/23 @ 13:08 hours, crews responded to Silver Lake Drive and East State Route 73 for a reported vehicle accident with injury. Upon arrival, crews found two cars involved in a crash with all occupants inside the vehicles. Crews stabilized the cars and extricated one occupant using hydraulic spreaders. Medic crews transported one patient to Kettering Health Main Campus and one patient to Miami Valley Hospital South. After securing the site of hazards, crews released the scene to Clearcreek PD. Washington Township provided mutual aid assistance.

On 3/14, 3/15, and 3/16/23, Station 21 Staff participated in the Clearcreek Elementary Reading Program.


