








## Total Alarms


## Alarms by Service Type


## Response Percentages

# SIGNIFICANT RESPONSES

On 5/2/23 @ 15:45 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Clearcreek PD.

On 5/4/23 @ 07:49 hours, crews responded to Red Lion Five Points Road for a reported unconscious person. Upon arrival, crews found an unconscious person in a car. Crews also noted there was a gun in the car and contacted Springboro PD. Officers from Springboro, Clearcreek, and the Warren County Tactical Response Team arrived on scene and woke the occupant. Once the occupant was out of the vehicle, Medic crews assessed the patient and found no medical needs. Crews released the scene to Clearcreek PD and returned to service.

On 5/10/23 @ 02:03 hours, crews responded to a residence for a reported shooting. Upon arrival, crews found a patient with a gunshot wound. Crews initiated ALS procedures and transported the patient to Kettering Health Main Campus.

On 5/10/23 @ 14:53 hours, crews responded to South Main Street for a reported vehicle accident. Upon arrival, crews found a single vehicle on the sidewalk, that crashed into a streetlight. The driver was out of the car and reported no injury. Crews secured live-wires from the streetlight that were on the sidewalk. Finding no additional hazards, crews released the scene to Springboro PD and Springboro Road Maintenance.



On 5/10/23 @ 20:11 hours, crews responded to Crown Point Drive for a reported building fire. Upon arrival, crews found a single-story house with smoke showing. Investigation showed fire in the garage. All occupants evacuated the building. Crews extinguished the fire using a handline and checked for extension. Finding no additional hazards, crews performed ventilation. Washington Township provided mutual aid assistance. The estimated property damage from fire is \$40,000.

On 5/12/23 @ 23:33 hours, crews responded to Lownes Court for a reported building fire. Upon arrival, crews found a residential structure fully involved in fire. Neighbors informed crews that the house was unoccupied. Crews established a handline to mitigate the exposure to adjacent buildings, while the Ladder 22 Aerial Tower Operator initiated the Aerial Master Stream, and the Fire Apparatus Operator of Rescue 21 placed the deck gun into operation to attack the main building fire. Additionally, crews applied foam via handline to extinguish the fire. Crews checked for heat signatures and performed ventilation. Additionally, crews checked for extension and heat signatures to the neighboring homes. Determining no further hazards, crews released the scene to Springboro PD and the Ohio State Fire Marshal. Miami Valley Fire District, Washington Township, and the City of Franklin provided mutual aid assistance. The estimated property damage due to fire is \$380,000.





On 5/15/23 @ 16:26 hours, crews responded to a mutual aid into Hamilton Township for a Warren County Technical Rescue Team (WCTRT) callout. Upon arrival, crews found a vehicle into a house. Firefighter Salas assumed command of the WCTRT to assist in shoring up the structural damage caused by the collision. District staffing was maintained during this incident.



On 5/15/23 @ 19:23 hours, crews responded to a mutual aid into Wayne Township for a reported building fire. Upon arrival, crews found a single-story automotive garage with smoke showing. The business owner notified crews that a powder coat oven caught fire, but the fire was out. Investigation showed significant smoke but no fire. Crews established a handline to cool the oven due to high heat and performed ventilation.

On 5/20/23 @ 20:21 hours, crews responded to North State Route 48 for a reported motor vehicle accident with injuries. Upon arrival, crews found a truck and a motorcycle involved in a collision with two patients lying in a ditch. Crews extricated the patients from the ditch. Medic 23 initiated ALS procedures and transported one patient to Kettering Health Main Campus. Washington Township transported the second patient. Crews secured the site of hazards and released the scene to Clearcreek PD.

On 5/20/23 @ 23:30 hours, crews responded to North State Route 48 and East Lytle Five Points Road for a reported vehicle accident with fire and entrapment. Upon arrival, crews found two vehicles involved in a collision, with two people entrapped in one car and fire involvement in both vehicles. Crews deployed the front hose line from Ladder 22 to extinguish the fire and performed patient extrication. Crews transported one patient to Kettering Health Main Campus. Crews determined two patients were DOA. Crews secured the site of hazards and released the scene to Clearcreek PD and Ohio State Patrol. Washington Township provided mutual assistance.

On 5/21/23 @ 16:10 hours, crews responded to a residence for a reported unconscious person. Upon arrival, crews found a patient in cardiac arrest and initiated ALS procedures. A family member provided a valid Do Not Resuscitate Order, ceasing patient care. Medical control provided a field termination of resuscitation efforts order. Crews contacted the coroner and released the scene to Clearcreek PD.



On 5/22/23 @ 16:28 hours, crews responded to North State Route 741 for a reported vehicle accident with injuries. Upon arrival, crews found a dump truck off the roadway with one person entrapped. Crews stabilized the vehicle, extricated the occupant, and transported the patient to Kettering Health Main Campus. Crews secured the site of hazards and released the scene to Clearcreek PD.



On 5/24/23 @ 20:50 hours, crews responded to a nursing home for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest. Crews initiated ALS procedures and transported the patient to Atrium Medical Center.

On 5/28/23 @ 22:41 hours, crews responded to Sycamore Creek Drive for a reported building fire. Upon arrival, crews found a residence with smoke showing. Springboro PD applied dry chemical to a fire in the garage prior to arrival. Crews established a handline to extinguish the remaining fire. Once extinguished, crews checked for extension and performed ventilation. All occupants evacuated the building and there were no reported injuries. Miami Valley Fire District provided mutual aid assistance. The estimated property loss due to fire is \$200.



On 5/30/23 @ 08:31 hours, crews responded to a mutual aid into Turtlecreek Township for a reported structure fire. Upon arrival, crews found a residential building involved in fire. Crews remained on-scene to assist where needed until released by command.



On 5/30/23 @ 10:44 hours, crews responded to a mutual aid into Wayne Township for a reported vehicle accident with injuries. Upon arrival, crews found a semi-truck and a van involved in a collision with one person entrapped and one confirmed fatality. Crews assisted Wayne Township in extricating the patient using the hydraulic spreader. Crews initiated ALS procedures and transferred patient care to CareFlight.



On 5/30/23 @ 12:21 hours, crews responded to Stanton Drive for a reported building fire. Upon arrival, crews found active fire on the roof, between solar panels and the shingles. Crews established a handline to knock down the fire in the attic. Crews then laid tarps to protect the property under the solar panels and initiated the aerial water tower to extinguish the remaining fire. Crews then extinguished hotspots and embers in the attic and performed ventilation. The City of Franklin, Washington Township, and Miami Valley Fire District provided mutual aid assistance. The estimated property damage due to fire is \$150,000.
