Station 24 Updates

In August, construction crews made impressive progress on Station 24. HVAC work continued throughout the Administration and Day Room areas. Plumbing crews continued installing water lines, completed the floor drains in the Mezzanine, hung above-ceiling cast iron, and installed carriers for toilets. Electrical rough-in was installed throughout the building and technicians installed the generator. Masonry crews continued working on the brick veneer. They completed the South and East Apparatus Bay and began work on the Administrative wing. Crews installed roof trusses over the Administration area. Additional work included the sprinkler system rough-in, drywall work, door frame installation throughout the building, and concrete and structural steel work. The City of Springboro conducted an inspection of wall frames and gave approval to begin hanging drywall.






Alarms by Service Type


Property Loss from Fire

Significant Responses

On 8/1/24 at 14:36 hours, crews responded to a residence for a reported gunshot wound. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Springboro PD.

On 8/1/24 at 18:33 hours, crews responded to Willow Grove Drive for a reported lightning strike. Upon arrival, crews found a residence with a large hole in the gable on the side of the house. The homeowner informed crews that he witnessed the strike. Crews checked the residence for hazards. Investigation found several breakers blown, but no heat signatures from the strike. Crews shut off the main breaker to the house and advised the homeowner to have an electrician inspect the residence before restoring power. Washington Township provided mutual aid assistance.




On 8/2/24 at 00:23 hours, crews responded mutual aid into Waynesville for a reported building fire. Upon arrival, crews found a two-story residence with fire showing. Crews assisted with extinguishing the fire, salvage, and overhaul until released by command.

On 8/7/24 at 08:19 hours, crews responded to West Central Avenue for a reported motor vehicle accident with injuries. Upon arrival, crews found two vehicles involved in a crash with a bystander and a Warren County Deputy performing CPR on one patient. Crews initiated ALS procedures and transported one patient to Kettering Health Franklin. Miami Valley Fire District transported another patient to Atrium Medical Center. Crews stabilized the vehicles and mitigated hazards. Finding no additional hazards, crew released the scene to Springboro PD. Miami Valley Fire District provided mutual aid assistance.

On 8/7/24 at 23:42 hours, crews responded to a nursing home for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest with staff performing CPR. Crews initiated ALS procedures with no response from the patient. Medical Control provided a field termination of resuscitation efforts order. Crews contacted the coroner and released the scene to Springboro PD.

On 8/10/24 at 04:21 hours, crews responded to a residential street for a reported cardiac arrest. Upon arrival, crews found a patient intoxicated, with abrasions from a fall. Crews initiated ALS procedures and transported the patient to Atrium Medical Center.

On 8/11/24 at 08:17 hours, crews responded to Vicki Lane for a reported structure fire. Upon arrival, crews found a garden shed with smoke showing from the eaves. Investigation showed a lawn mower on fire inside the structure. Crews used a handline to extinguish the fire. Wayne Township provided mutual aid assistance. The estimated property loss due to the fire is \$10,000.



On 8/11/24 at 10:31 hours, crews responded to North State Route 48 for a reported vehicle accident with injuries. Upon arrival, crews found two cars involved in a crash with one car rolled on its top. Ladder 22 shielded the scene while crews stabilized the vehicles and extricated one entrapped person. Crews transported one patient to Atrium Medical Center. After securing the site of hazards, crews released the scene to Ohio State Patrol and Clearcreek PD.



On 8/13/24 at 13:24 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews determined the patient was DOA. Crews contacted the coroner and released the scene to Clearcreek PD.

On 8/15/24 at 18:07 hours, crews responded to a residence for a reported cardiac arrest. Upon arrival, crews found a patient in cardiac arrest with a bystander performing CPR. Crews initiated ALS procedures with no response from the patient. Medical Control provided a field termination of resuscitation efforts order. Crews contacted the coroner and released the scene to Clearcreek PD.

On 8/17/24 at 22:07 hours, crews responded to I-75 Northbound and West State Route 73 for a reported vehicle fire. Upon arrival, crews found a truck with smoke showing. Springboro PD confirmed seeing flames and used a fire extinguisher. Crews used a bumper line to mitigate heat remaining in the rear axle. The estimated property loss due to fire is \$2,000.





All exterior walls were intact and there were no occupants during the collapse. Crews secured the site and ensured all utilities were controlled and shutdown as appropriate. Finding no additional hazards, crews released the scene to the Warren County Building Department.



On 8/25/24 at 17:07 hours crews responded to Northbound I-75 for a reported passenger vehicle fire. Upon arrival, crews found a box truck involved in fire. Crews blocked the right two lanes of the highway and extinguished the fire using a bumper line. Additionally, crews applied foam to ensure the fire was out. Miami Valley Fire District provided mutual aid assistance. The estimated property damage due to fire is \$21,000.
