Ms. Anspach moved to approve Resolution #4445 amending the Permanent Appropriations Resolution with supplemental appropriations. The motion was seconded by Mr. Gabbard and upon roll call the vote was as follows: Mr. Anspach-yea; Mr. Gabbard-yea; Mr. Wade-yea. A copy of the resolution is attached to these minutes and deemed a part of this record as if fully rewritten herein.

Mr. Gabbard moved to approve Resolution #4446 authorizing the Township Administrator to enter into a renewal agreement for the Township's two T-1 lines. The cost will remain the same at \$196.00 per month per line. The motion was seconded by Ms. Anspach and upon roll call the vote was as follows: Mr. Gabbard-yea; Ms. Anspach-yea; Mr. Wade-yea. A copy of the resolution is attached to these minutes and deemed a part of this record as if fully rewritten herein.

Assistant Fire Chief Tim Simpson gave the August monthly report.

Ms. Anspach moved to accept the resignation of part time firefighter/EMT Jeff Garey effective September 21, 2013. The motion was seconded by Mr. Gabbard and upon roll call the vote was as follows: Ms. Anspach-yea; Mr. Gabbard-yea; Mr. Wade-yea.

Mr. Gabbard moved to employ as fulltime Firefighter/Paramedics Douglas Eagan, Matthew S. Hughes, and Matthew D. Kohl. All three have starting salaries of \$18.08 per hour. Mr. Kohl will begin September 16, 2013, while Mr. Eagan and Mr. Hughes will report to work on September 30, 2013. The motion was seconded by Ms. Anspach and upon roll call the vote was as follows: Mr. Gabbard-yea; Ms. Anspach-yea; Mr. Wade-yea.

Ms. Anspach moved to approve sending up to two Firefighter/Paramedics to the Ohio Fire Executive Program at a cost not to exceed \$10,000.00 for each position. Captain Kent Clary will be one the people attending. The cost includes tuition, room and all meals. The motion was seconded by Mr. Gabbard and upon roll call the vote was as follows: Ms. Anspach-yea; Mr. Gabbard-yea; Mr. Wade-yea.

Mr. Gabbard moved to allow the Fire District to apply for the Federal Emergency Management Agency (FEMA) 2013-2014 Assistance to Firefighters Grant. The motion was seconded by Ms. Anspach and upon roll call the vote was as follows: Mr. Gabbard-yea; Ms. Anspach-yea; Mr. Wade-yea.
