Mr. Wade opened the meeting, and led in the Pledge of Allegiance.

Mr. Muterspaw moved to approve the regular meeting minutes from May 12, 2014. The motion was seconded by Mr. Gabbard and upon roll call the vote was as follows: Mr. Muterspaw-yea; Mr. Gabbard-yea; Mr. Wade-yea.

Mr. Gabbard moved to approve Electronic Fund Transfers (EFTs) 975-2014 through 1071-2014 and pending warrants #18058 through #18136. The motion was seconded by Mr. Muterspaw and upon roll call the vote was as follows: Mr. Gabbard-yea; Mr. Muterspaw-yea; Mr. Wade-yea.

Mr. Muterspaw moved to approve Resolution #4546 approving Anthem Blue Cross and Blue Shield provider recertification for the Clearcreek Fire District and authorizing the Township Administrator to execute the agreement The motion was seconded by Mr. Gabbard and upon roll call the vote was as follows: Mr. Muterspaw-yea; Mr. Gabbard-yea; Mr. Wade-yea. The Firefighter/Paramedics include Nunzio Fiorito, Kyle Lalich, Matthew Lalich, Levi Sargent, Adam Stafford, Barry Deaton, Ross Moffitt, Peter Richison and Michael Toothman. The motion was seconded by Mr. Gabbard and upon roll call the vote was as follows: Mr. Muterspaw-yea; Mr. Gabbard-yea; Mr. Wade-yea.

Mr. Gabbard moved to hire Justin D. Null to a probationary (one-year orientation period) Fire Lieutenant/Paramedic position at the rate of \$23.90 per hour effective June 9, 2014. The motion was seconded by Mr. Muterspaw and upon roll call the vote was as follows: Mr. Gabbard-yea; Mr. Muterspaw-yea; Mr. Wade-yea.

Mr. Muterspaw moved to appoint Brandon M. Rentz and Matthew J. Walker to probationary (one-year orientation period) Firefighter/Paramedic positions at the rate of \$18.53 per hour effective June 9, 2014.
