Mr. Wade opened the meeting, and led in the Pledge of Allegiance.

Mr. Muterspaw moved to approve the regular meeting minutes of January 23, 2017. The motion was seconded by Mr. Gabbard and upon roll call the vote was as follows: Mr. Muterspaw-yea; Mr. Gabbard-yea; Mr. Wade-yea.

Mr. Gabbard moved to approve warrants #23974 through #24032 and electronic fund transfers #0182-2017 through #0268-2017. The motion was seconded by Mr. Muterspaw and upon roll call the vote was as follows: Mr. Gabbard-yea; Mr. Muterspaw-yea; Mr. Wade-yea.

Mr. Muterspaw moved to appoint Trustee Jason Gabbard as interim administrator until a permanent solution can be found. Mr. Gabbard will receive no additional compensation. The motion was seconded by Mr. Wade and upon roll call the vote was as follows: Mr. Muterspaw-yea; Mr. Wade-yea; Mr. Gabbard-abstain.

At 9:18 a.m., Mr. Gabbard moved to approve Resolution #4993 authorizing an executive session to consider the appointment, employment, dismissal, promotion, demotion or compensation of a public employee.
