Mr. Wade opened the meeting, and led in the Pledge of Allegiance.

Mr. Muterspaw moved to approve the regular meeting minutes of February 27, 2017. The motion was seconded by Mr. Gabbard and upon roll call the vote was as follows: Mr. Muterspaw-yea; Mr. Gabbard-yea; Mr. Wade-yea.

Mr. Gabbard moved to approve warrants #24198 through #24289 and electronic fund transfers #0367-2017 through #0551-2017. The motion was seconded by Mr. Muterspaw and upon roll call the vote was as follows: Mr. Gabbard-yea; Mr. Muterspaw-yea; Mr. Wade-yea.

Mr. Gabbard moved to approve Resolution #5001 creating the permanent appropriations resolution for 2017. The contract will continue to be with Buckeye Ecocare at an annual cost of \$16,560.60. The motion was seconded by Mr. Gabbard and upon roll call the vote was as follows: Mr. Muterspaw-yea; Mr. Gabbard-yea; Mr. Wade-yea.

Road Superintendent Mr. Smith presented an update on removal of LED stop signs from Township Line Road. Since a working traffic light is now at that intersection, Mr. Smith moved the LED stop signs to the East/West direction at the intersection of Red Lion Five Point and Lower Springboro roads.

The Board is considering a request by Mr. Smith to spend \$5,614.00 on three sweeps of Township roads this summer. Mr. Smith is looking into possible grant money from the County Engineer's office to see if that will cover some of the costs.

Mr. Palmer presented the Zoning Department's February monthly report.

Mr. Gabbard moved to set a public hearing regarding the Sproat property on April 10, 2017 at 5:30 p.m. The motion was seconded by Mr. Gabbard and upon roll call the vote was as follows: Mr. Gabbard-yea; Mr. Muterspaw-yea; Mr. Wade-yea
