The Clearcreek Township Trustees met in regular session at 5:30 p.m. with the following members present: Mr. Gabbard and Mr. Wade. Mr. Muterspaw was absent.

Mr. Wade opened the meeting, and led in the Pledge of Allegiance.

Mr. Gabbard moved to approve the regular meeting minutes of August 28, 2017. The motion was seconded by Mr. Gabbard and upon roll call the vote was as follows Mr. Gabbard-yea; Mr. Wade-yea.

Mrs. Oda gave the Fiscal Officer's report, and noted the Board had received updated copies of the appropriation, revenue and fund status reports. Additionally, the Township has \$11,107,246.41 in its checking and investment accounts.

Mr. Gabbard moved to approve warrants #25342 through #25409 and electronic fund transfers #1752-2017 through #1852-2017. The motion was seconded by Mr. Wade and upon roll call the vote was as follows: Mr. Gabbard-yea; Mr. Wade-yea.

Under public comments, residents Linda Roberts and Diane Smith spoke about their concern for storm water run-off issues in the southern portion of the Township.

Officers Charles Sweet and Geoffrey Getter were recognized for outstanding lifesaving efforts for their work at an August 3, 2017 event in which they saved the life of Township resident James Westendorf. Doctors confirmed that had Officers Getter and Sweet not acted and performed CPR at the site of the incident, the resident would have died.

At 5:38 p.m. Mr. Gabbard moved to adjourn the public session and enter into a Public Hearing to consider the adoption of the Hunter-Red Lion Area Plan. The motion was seconded by Mr. Wade and upon roll call the vote was as follows: Mr. Gabbard-yea; Mr. Wade-yea.

Greg Orosz from the Warren County Planning Department summarized the work performed by more than 400 man hours that were volunteered by residents, Township officials, and others. The Hunter-Red Lion plan can be viewed on the Township's website.

Also speaking on behalf of the plan were residents Paul Pomeroy, Diane Smith and John Grier.

The Board concluded the Public Hearing at 6:01 p.m. Mr. Gabbard moved to approve Resolution #5049 adopting the Hunter-Red Lion Area Plan. The motion was seconded by Mr. Wade and upon roll call the vote was as follows: Mr. Gabbard-yea; Mr. Wade-yea.
