Mr. Muterspaw moved to approve the regular meeting minutes of January 22, 2018. The motion was seconded by Mr. Gabbard and upon roll call the vote was as follows: Mr. Muterspaw-yea, Mr. Gabbard-yea; Mr. Wade-yea.

Mr. Gabbard moved to approve warrants #26265 through #26413 and electronic fund transfers #295-2018 through #502-2018. The motion was seconded by Mr. Muterspaw and upon roll call the vote was as follows: Mr. Gabbard-yea; Mr. Muterspaw-yea; Mr. Wade-yea.

Mr. Muterspaw moved to approve Resolution #5084 amending the 2018 temporary appropriation resolution with supplemental appropriations.
